

### CORRIGENDUM

Our Circular No. 16/2007 was sent in the normal format by mail to all the General Secretaries of the Zonal Units and the Secretary Standing Committee (GI). Copies of the Circular printed in colour were then sent to all the units by courier. The copies sent by e-mail were all right, but in the printed version, the last line at the bottom of the page three **"and attempting to disrupt the unity of the people. The UPA government has given up the tested"** was missing.

The paragraph at the end of page 3 in the printed circular would read as:

"The major component of the UPA, Congress has shown no courage to fight the communal forces and this has resulted in the communal forces regrouping **and attempting to disrupt the unity of the people. The UPA government has given up the tested** long standing foreign policy and has shown willingness to be the junior partner of the US imperialism and in the process help secure the regional and strategic interests of United States."

We are sorry for the omission and request you to correct it as above in the printed circular.
