ORGANISATIONAL ACTIVITIES

In keeping with the decisions of the ECZIEA working committee meeting in Hazaribagh on 15-16 February 2015, all the divisional units under the zone have stepped up their organizational activities.

A. Strike against Insurance Bill: This stepped up activity was amply reflected in the performance of our divisional units (and ECZIEA as a whole) in the historic one day strike action of 9th March 2015, against the passage of the Insurance Laws (Amendment) Bill 2015. The zone as a whole registered a strike percentage of an astounding 97%. Out of 33 divisions at the all India level that registered strike percentage of more than 95%, nine divisions belonged to the east central zone. This indeed is a commendable performance. We profusely thank and congratulate all our comrades and call upon them to remain prepared for meeting all challenges in the future.

Officers, Agents and Development Officers attended the meeting. Sri N.P. Chawla, Zonal Manager, LIC East Central Zone, inaugurated the Convention. Sri P.B.Roy, RM(P&IR), Sri P.C.Paikray, Sr. Divisional Manager Patna D.O. I, Sri Ashok Kumar, Sr. Divisional Manager, Patna D.O. II, Sri S.N.
