

इन 60 वर्षों में इन्श्योरेन्स वर्कर ए.आई.आई.ई.ए. के संघर्षों का सबसे शक्तिशाली हथियार बन गया है। यह अपने मुल उद्देश्यों के प्रति वफादार बना रहा है। यह शक्तिशाली तरीके से कर्मचारियों के हितों को आगे बढ़ाने का काम करता रहा है तथा इसने निगम को देश का सर्वश्रेष्ठ वित्तीय संस्थान बनाने में महत्वपूर्ण योगदान किया है। यह मजदर वर्ग की एकजुटता के लिये काम करता रहा है और केवल भारत में ही नहीं बल्कि अन्तराष्ट्रीय एकजुटता के विकास में भी यह भूमिका निभाता रहा है। पत्रिका ने उच्चतम मानकों व समझौता-विहीन संपादकीय नीति को बनाए रखा है। यह शिक्षा प्रदान करता रहा है तथा अपने पाठकों में राजनीतिक व वर्गीय चेतना पैदा करता रहा है। पत्रिका ने केवल बीमा कर्मचारियों के ही नहीं वरन आम लोगों के जीवन व जीवन पद्वति पर प्रभाव डालने वाले विभिन्न विषयों पर विचार-विमर्श करते हुए सच को उन तक पहुँचाया है। भारी दवाबों के बावजूद यह सत्ता के सामने खड़ा रहा है। शासन के सामने सच को लाना ही हमेशा इसका समझौता-विहीन सिद्धान्त रहा है।

इन्श्योरेन्स वर्कर को अनेक कष्टों व मुसीबतों से गुजरना पड़ा है। ओटोमेशन संघर्ष के दौरान इस पर हमला हुआ। ओटोमेशन के बड़े आन्दोलन के दौरान इसने ओटोमेशन के समर्थन में दिये गये इश्तहार को निकालने से मना कर दिया। इस पत्रिका को आपातकाल के काले दिनों के विरूद्व भी अमानवीय हमलों का सामना करना पड़ा जब किसी असहमति की आज्ञा नहीं थी। उन काले दिनों में उसने सेंसर की कड़ी कैंची सहन करने से इन्कार कर दिया था तथा प्रतिरोध के रूप में संपादकीय का पन्ना खाली छोड़ दिया था। यह भारतीय संविधान व लोकतन्त्र पर हमले के खिलाफ शक्तिशाली प्रतिरोध था। पत्रिका व ट्रेड यूनियन को इस प्रतिरोध के लिये दमन का भी सामना करना पड़ा परन्तु लोकतन्त्र की रक्षा के लिये यह मूल्य चुकाना वाजिव था। इसमें कोई आश्चर्य नहीं कि आज इन्श्योरेन्स वर्कर देश के मध्य वर्गीय ट्रेड–यूनियन आज भी चुनौती जारी है। यह ऐसा समय है जब असहमति को देशद्रोह समझा जाता है तथा सरकार की किसी आलोचना को स्वयं देश की आलोचना के बराबर रख दिया जाता है। अभिव्यक्ति की स्वतन्त्रता पर कपटपूर्ण हमले हो रहे हैं। लोकतान्त्रिक संस्थाओं को सुनियोजित तरीके से कमजोर किया जा रहा है। घृणा की नीतियों से पूरा वातावरण भर गया है। समाज का सांप्रदायिक व जातिवादी आधार पर धुवीकरण हो रहा है। समानता के नाम पर संस्कृति, विविधता और समृद्वि की समन्वयता पर योजनाबद्व तरीके से हमले हो रहे हैं। बहुसंख्यकवाद का दृष्टिकोण जबरदस्ती थोपा जा रहा है। नव–उदारवादी आर्थिक नीतियों से भारत रूस के बाद दुनियां का दूसरा सबसे बड़ा असमान समाज हो गया है।

आन्दोलन की सबसे सम्माननीय पत्रिका बन गई है।

इन्श्योरेन्स वर्कर इस हानिकारक घटनाक्रम पर चुप नहीं रह सकता। इसे राष्ट्रीय एकता, सांप्रदायिक सौहार्द तथा नव–उदारवाद की आर्थिक नीतियों के विरूद्ध प्रतिरोध की आवाज उठानी पड़ी और कर्मचारियों को एकजुट करना पड़ा। यह बिना किसी डर के ऐसा कर रहा है। आज की सरकार को यह पसंद नहीं है। यह इस तथ्य से यह ज्ञात होता है कि एल.आई.सी. ने इन्श्योरेन्स वर्कर के लिये एक विज्ञापन देना अचानक बंद कर दिया जोकि वह इस पत्रिका को प्रारम्भ से देता आ रहा था। लगातार पुछने के बाद भी इस विज्ञापन को बंद करने के कारण नहीं बताये गये। स्पष्ट रूप से यह राजनीतिक बदले की कार्यवाही थी लेकिन इन्श्योरेन्स वर्कर को परेशान नहीं किया जा सकता। इन्श्योरेन्स वर्कर के लिये विज्ञापन के धन का कोई मुद्दा नहीं है। इसे अपने संस्थान के प्रति गहरा लगाव है और यह उसके हितों को आगे बढ़ाने के लिये काम करता रहेगा तथा नव-उदारवाद के कपटपूर्ण हमलों से अपने संस्थान की रक्षा करने के लिये केवल बीमाकर्मियों को ही नहीं बल्कि भारतीय समाज के सभी प्रगतिशील वर्गों को एकजुट करने के लिये सभी प्रकार के प्रयास करता रहेगा।

## AIIEA Submits Charter of Demands to LIC and GIPSA managements

IIEA submitted the Charter of Demands for revision of wages and improvements in other service conditions to the managements of both GIPSA and LIC on 2<sup>nd</sup> August 2017. A delegation of AIIEA consisting of Comrades Amanulla Khan, President; V.Ramesh, General Secretary; K.V.V.S.N. Raju, Vice President and Sanjay Jha, Secretary (Standing Committee), General Insurance submitted the Charter of Demands to the Chairman GIPSA and CMD of New India Assurance Co Ltd., Sri G. Sreenivasan at Mumbai on 2<sup>nd</sup> August 2017. The delegation of AIIEA demanded a wage revision of 40% effective from 01 August 2017 and substantial improvements in the amenities and non-monetary benefits for the employees. The Chairman GIPSA appreciated the rationale behind AIIEA's demand for 40% wage revision and sought AIIEA's help in successfully meeting the challenges before public sector general insurance industry.

In the afternoon, the AIIEA delegation consisting of Comrades Amanulla Khan, V. Ramesh, H.I.Bhatt (Joint Secretary, AIIEA), Shreekant Mishra (Joint Secretary, AIIEA) and V.S. Nalwade (Vice President, AIIEA) met the Chairman, LIC and submitted the Charter of Demands for LIC. Along with Sri V.K.Sharma, Chairman LIC, Sri Hemant Bhargava, Managing Director; Sri Sharad Srivastava, ED (Personnel); Chief (Personnel) and other officials of personnel department were present in the meeting. The AIIEA delegation placed a demand for 40% wage rise effective from 01 August 2017 with hundred percent merger of the D.A. as on that date and appropriate loading on this to frame the new scales of pay.

The delegation made it absolutely clear that wage revision in LIC should be based on the strength and paying capacity of the institution and it should commensurate with the hopes and aspirations of the employees. The AIIEA delegation demanded that there should be substantial increase in all allowances payable to the employees and due attention be given to improvement of retiral benefits.

While explaining the rationale behind our demand for a 40% wage hike, the AIIEA delegation emphasised on the need to bring about certain improvements in the LIC Pension Scheme 1995. The delegation demanded that 100% D.A. neutralisation be given to all pensioners and family pensioners irrespective of the date of retirement, family pension should be increased on the basis of improvements in Central Government and RBI, that pension should be revised upwards with every wage revision. The demand for one more option to join the 1995 Pension Scheme was also reiterated. The delegation pointed out to the Chairman that this issue is pending for a very long time and need to be vigorously pursued on the strength of a very strong financial performance by the Corporation.

The AIIEA informed the Chairman that the Charter contains some non-monetary demands. These demands can be met without waiting for the completion of the process of wage negotiations. The delegation referred to the long pending demand for improvement in the Promotion Policy. Our demand for elimination of subjective factors, interview and openness of the Confidential Reports were reiterated. We demanded reduction in the eligibility years for promotion to the post of Record Clerk. It was also pointed out that some provisions of the Staff Regulations had become quite archaic and out of sync with the present-day realities. The delegation therefore demanded that there was a need to revisit some provisions of the Staff Regulations and these had to be recast in the line of the changes made to the Service Rules of central government employees. The AIIEA also raised the issue of Industrial Democracy and pointed out that denial of the basic democratic right of recognition to the majority union was unacceptable in a public sector organisation like LIC.

Responding on behalf of the management, the Chairman appreciated AIIEA's justification of the demand for a forty per cent wage rise and noted the positive contribution of the employees in furtherance of LIC's interests in a competitive scenario. He said that the decline in number of policies being experienced in recent years was a cause of anxiety and had to be arrested. He sought AIIEA's co-operation in taking this message forward and sensitising the employees on the role and significance of number of policies.

The AIIEA took this opportunity to reiterate the demand that all that had been committed by the management during the last round of wage negotiations but had not yet materialised till now should be redeemed without further delay. Particular emphasis was given to the issue of 5 Day Week and One more option for Pension. The issues pertaining to residual Part Time employees, CGIT, Ex-gratia in lieu of Bonus were also discussed. The management assured to pursue these issues with the government without any let up. LIC management was preceded by a massive employees' meeting in front of Yogakshema building of Central Office. Hundreds of employees of Mumbai centre and offices adjacent to Mumbai attended the meeting. Remarkably, a large number of employees from Thane and places as far as Nashik, Pune, Satara, and other centres had come to participate in the Gate Meeting. Com. H.I.Bhatt, Joint Secretary AIIEA and General Secretary WZIEA conducted the proceedings and Com. Amanulla Khan, Com. V.Ramesh and Com. Shreekant Mishra addressed the gathering.

Comrades, with the submission of the Charter to the managements of LIC and GIPSA, one phase of the struggle is over. This phase of the struggle that is, framing of the Charter of Demands was a relatively easier phase. The real struggle will start now. Neither the strength of our arguments nor the performance of public sector insurance industry alone is sufficient to fetch us a wage revision in the manner we have framed our demands. In a class divided society like ours, the rulers will constantly try to belittle our performances and downplay our contributions to deny us a legitimate share in what is legitimately due to us. Our struggle for Charter of Demands has to contend with the government policies on labour and wages, which unfortunately remain very hostile. The Working Committee of AIIEA at Surat made a critical analysis of the political and economic situation to conclude that despite the genuineness of our demands, it would require a long and protracted battle to win them over. Therefore, insurance employees have to remain prepared for such a struggle to secure their just demands.

### Final option on Pension : Committee on Subordinate Legislation on RBI Pension Scheme

The AIIEA has been vigorously pursuing the issue of a final pension option. The letter of AIIEA dated 16.8.2017 addressed to Chairman LIC is reproduced. The same is self-explanatory.

"Please recall the discussions we had with you on 2<sup>nd</sup> August 2017 while submitting our Charter of Demands. When we requested you to immediately settle the issue of Final Option on Pension to join the LIC Employees Pension Scheme 1995, you informed us that the government has written to LIC that its recommendation for such an option is regretted. We said that this position is unacceptable as the demand is absolutely genuine and gave the following arguments to back our demand:

- 1. The Pension Scheme was notified on 28/6/1995 and the employees were asked to exercise the option to join within 120 days.
- 2. The second option was given to join the scheme within just 18 months between May to mid-August 1997.
- 3. Even after the second option a small number of employees did not exercise the option.
- 4. They did not exercise the option in view of the fact that between 28/6/1995 and May 1997, there was no change in the interest regime nor were there any improvements in the pension scheme.
- 5. But after the wage revision effective from 1.8.1997 which was notified on 22.6.2010, many improvements have come about in the pension scheme. Prominent are:
  - (a) 100 percent D.A neutralisation
  - *(b) inclusion of dependent parents as eligible to receive family pension*
  - (c) inclusion of dependent widowed/ divorced daughter as eligible to receive family pension and

(d) improvement in the family pension

- 6. The principle of natural justice demands that employees should be given an option to join the scheme after taking into account the improvements brought about.
- 7. In the RBI options were given four times whenever improvements were made in the pension scheme.
- 8. In the Banking industry the second option was given in 2010 after the improvements

in Pension Scheme came about and this helped the employees take a considered decision.

We requested you to take up this issue with the government in the light of the above compelling facts as also on the basis of the fantastic financial performance recorded by LIC. We are happy that you assured to take up this issue at the highest level in the government and you also agreed that considering the small percentage of employees who desire a pension option, the cost involved is not substantial and can be absorbed by LIC. In fact the letter of LIC to the government written on July 4, 2014 makes strong recommendation for giving a final option to employees to join the pension scheme 1995.

We are happy to inform you of a new development on the issue of Pension. The RBI had recommended to the government to give a final option for the 5<sup>th</sup> time to its employees. We understand that the government is yet to act on this recommendation. In the meantime, The Committee on Subordinate Legislation of Parliament under the chairmanship of Shri Dilipkumar Mansukhlal Gandhi comprising of 15 Members of Parliament studied THE RBI PENSION REGULATIONS 1990 and submitted its Report to the Lok Sabha on 10<sup>th</sup> August 2017. This committee after a detailed examination of the RBI Pension Regulations and after hearing both the RBI and the Finance Ministry officials has unanimously recommended that RBI should be allowed to give another Pension Option to its employees who could not exercise the options on the earlier four occasions.

This recommendation of the Committee on Sub-ordinate Legislation of Parliament clearly strengthens the case of LIC to seek immediate approval of the government to give a final option on pension to the employees to join the LIC Employees Pension Scheme 1995.

We trust and hope that you will move speedily to resolve this long pending demand.'

### JOINT ACTION BY TRADE UNIONS

THE joint national convention of central trade unions and independent industrial federations held at Delhi on August 8, 2017 chalked out a programme of joint campaign and struggles against the anti-worker and antipeople policies and the growing authoritarian tendencies of the Modi led BJP government at the centre.

The national convention unanimously decided to organsie a massive three days' 'padav' ( dharna) near parliament from November 9-11. It called upon the working class of the country to prepare itself for country wide indefinite general strike in the future. The 'padav' will be preceded by extensive joint campaign through state, district, block, industrial centre, factory level joint conventions.

The huge participation of workers from all over the country – from far off Tamil Nadu and Kerala in the south to the strife torn state like Jammu and Kashmir in the north, from all sectors, organised and unorganised, public and private – shows the determination of the working class of the country to fight against the attacks on their livelihoods and working conditions by the BJP led government wedded to the neo-liberal agenda. The Talkatora Stadium was overflowing with workers standing on the floor and standing packed in the passages. Despite this, almost half the workers had to remain outside the hall.

The joint convention was organised by all the central trade unions and almost all the

independent national federations of different sections of employees, except the BMS which has opted out of joint struggles since the BJP came to power at the centre. In addition to INTUC, AITUC, HMS, CITU, AIUTUC, TUCC, SEWA, AICCTU, UTUC and LPF, the independent national federations and unions of employees in the central government, state government, insurance, banks, defence, railways, BSNL, electricity, coal, steel, energy, petroleum, road transport, air transport, water transport, port and dock, mining, IT, PSUs etc participated in the convention.

The convention strongly condemned the authoritarian measure of the government depriving the INTUC representation in the tripartite and bipartite forums and committees including in the international forums. It denounced the measure as a heinous onslaught on the rights of the entire trade union movement. It declared that the trade union movement in the country will not take it lying down. It pledged to fight it back with all its might.

The declaration placed by G Sanjeeva Reddy, president of INTUC was unanimously adopted by the convention amidst thunderous slogans after representatives of the ten central trade unions spoke in support of it. The AIIEA was represented by Com Anil, Bhatnagar, Vice-President and Com Naveen Chand, Joint Secretary. A large number of cadres belonging to AIIEA participated in the National Convention.

# LIC - Sixtyone Years of Service & Challenges

LIC has a very purposeful existence and it has the enormous goodwill of the people of the country. It has a committed workforce in all cadres and this will put it in good stead in facing the future challenges and onslaughts of the neoliberal agenda.

The cadres of AIIEA will continue to protect the light that illuminated millions of lives across the country for the last 61 years.

Life Insurance Corporation of India completes 61 years of glorious and purposeful existence on 1<sup>st</sup> September, 2017. LIC was formed to mobilise peoples savings and provide them complete security and efficient service. The LIC has been performing a glorious part in the nation building exercise.

With 8 Zonal offices, 113 Divisional Offices, 1, 15,394 employees and 11, 31, 181 agents-LIC is a huge organisation with omnibus presence across the length and breadth of the country. With a total premium incomeof Rs 3, 00,196 crores and total income of Rs 4,92,626 crores (for the Financial Year 2016-17) and with assets over Rs 25, 72,000 crores – the financial strength of LIC has no match. The total life fund of LIC is over and above Rs 23 lakh crores. The settlement of 98.34% of maturity claims and 99.63% of death claims reveal the excellent service performance of LIC.

In the year 2016-17, LIC achieved its First premium target in the month of February itself and secured TFPI of Rs 37859.87 crores with a growth rate of 47.07%. There is 27% growth rate in composite first premium income. Seventeen years after the opening of the insurance industry for private sector, LIC is still the market leader with a market share of 71.07% in premium income and 76.09% market share in policies.LIC has generated an investible surplus of Rs 3, 61,564 crore during 2016-17.LIC got 7.65% of average annualised vield on its investments of RS 2.60 lakh crores in State and Central Govt securities. Rs 41751 crores were invested in equities and Rs 19302.46 crores of profit was secured by the sale of investments in equities. As a

result of this increased income, a reversionary bonus of Rs 47387.44 crores is declared to the policyholders which was 34207.58 crores last year. In the same way there is increase in the dividend given to Govt of India from 1800 crores last year to 2494 crores this year.LIC is able to maintain its solvency ratio of 154.65% as against the statutorily required 150%.

As part of Corporate Social responsibility, LIC established Golden Jubilee Foundation Trustin the year 2006.The aim of the trust is to give relief to poor and distressed people. From this trust, funds are allocated for activities pertaining to educational advancement, medical relief and other objects of utility to the general public. Funds were provided for construction of school buildings, hospitals, libraries, old age homes, hostel buildings etc. As on 31.03.2017, Rs 88.06 crores were given to various projects numbering around 398.

What makes LIC so successful? When insurance industry was opened for private sector, many believed that the growth of LIC will decline and its market share will fall like the way it happened in Banking, Telecom and other sectors. Even in other countries wherever insurance industry was opened like in the South Asian countries, the public sector insurance crumbled to the onslaught of the private players. What is so special of LIC that its records in new business, generation of surplus and settlements of claims soared high even in the midst of stiff competition? It is the commitment of Officers, employees, Development Officers and agents that makes LIC a wonderful organisation. As Prof Noel Machado put it 'employees just don't work in LIC, they just live in LIC' and it

is this passion and love for the organisation that makes LIC a great organisation. It is acknowledged that AIIEA played a great role in creating that kind of consciousness.

After the formation of LIC in 1956 by amalgamating 245 private insurance companies, the Corporation took over 21000 employees in the clerical and supervisory cadres. Employees came from different companies and they were united under the banner of All India Insurance Employees Association. But their service conditions and pay scales were different and there were as many as 110 provident fund accounts each with a different set of rules. So the major challenge was to integrate employees as LIC employees and this can be possible only if there is uniformity in service conditions of all employees. All India Insurance Employees' Association demanded standardisation of wages and uniformity in service condition for all employees. AIIEA gave a call for the first ever strike on 5th December 1956 and the strike was a huge success. Later the Govt issued standardisation order on 1<sup>st</sup> June 1957 and this paved the way for integration of LIC employees under the leadership of AIIEA. In 1957, the Mundra scandal rocked LIC and there were allegations against the LIC's purchase of shares from troubled companies of Sri Harilal Mundhra. Parliament discussed this issue and MC Chagla committee was appointed to look into the allegations. The committee gave its report in 1958 and Finance Minister and top LIC officials resigned after the report was made public. Some vested interests tried to exploit the situation and campaigned against the idea of nationalisation itself. One of the important recommendations of the Chagla committee was to apply the provisions of Section 27A of the Insurance Act 1938 and as a result in August 1958 Section 27 A of the Insurance Act 1938 as amended was made applicable to LIC. The idea was to see that the funds of the Corporation should only be used for the benefit of policyholders and nation building and not for any extraneous purposes. LIC weathered this storm and today no one remembers Mundhra affair and in last 61 years LIC has earned a name for itself as non-corrupt organisation in the country and its employees are known for their honest and integrity.

In the use of technology LIC was always a step ahead of other organisations. From the unit record systems to the present day

advanced IT initiatives, LIC was the leader in the use of technology and this helped in the serving the policyholders and in managing the ever increasing scale of business operations. AIIEA welcomed the new technological initiatives in LIC whenever they were helpful for the growth of the organisation and not impacted employment opportunities. AIIEA was always in tune with times. Technology which threatens existing jobs and cuts down future employment opportunities is not acceptable to AIIEA. It is with this philosophy AIIEA struggled against automation in 1960s and successfully thwarted the attempts of the Management to install computer at Kolkata. It was historical struggle and protected the employment opportunities of the future generations. AIIEA which opposed automation agreed to FEAP installation programmes and further up gradation of technology keeping in view the changing times. AIIEA with its campaign and struggle could stall the privatisation moves of the Govt for almost for a decade in 90s. These ten years were helpful for LIC in consolidating itself technologically and when insurance sector was opened up LIC was ready to face the competition of private players. While allowing technology and other changes, AIIEA was successful in convincing the LICV management to set aside the recommendations of Booz Allen Hamilton which recommended for elimination of 45000 jobs in LIC. Due to the initiative of AIIEA, LIC adopted a development model which absorbed technology and the existing jobs also. It is the vision of AIIEA that protected the jobs and at the same time empowered LIC with new technology.

By the time LIC completed two decades in 1976, the annual volume of new business increased to eight-fold and it was operating from around 800 offices. LIC acquired national character and has become a premium financial institution of the country. LIC was expanding and was making difference to the economic wellbeing of the country through its investments mobilised from the people of the country. It was in this background the Govt appointed Era Sezhiyan committee in 1979 to study the working of LIC. The committee recommended for the splitting of LIC into five or more independent Corporations. Govt accepted this recommendations and the stage was set for the split of LIC. Here again it is the struggles of AIIEA which protected the monolithic character

of LIC and today when we celebrate the 6 decades of LIC, we have to remember that it is the campaign of the cadres of AIIEA and the intellectual acumen of the leadership of AIIEA that saved LIC from breaking into five or more small corporations.

With the advent of neoliberal policies, the Govt appointed a committee headed by R.N.Malhotra in 1993 which recommended for the opening up of insurance industry for foreign and Indian insurance companies. It also recommended for the privatisation of LIC by raising its capital to 200 crores and selling 50% of the increased equity to the public. AIIEA opposed the Malhotra committee recommendations and gave call sustained struggle. It is this gigantic struggle that has ensured that LIC still remains a 100 percent government holding corporation.


It is now 17 years that the insurance sector was opened up. But the dominance of LIC continues despite adverse policies of both the government and the regulator. There are continuous attempts to weaken the public sector insurance industry. The Government decision to sell the shares of the four public sector general insurance companies is condemnable. It also makes it clear that LIC would also face the threat of government policies of privatisation. We have to be vigilant and should continue our struggle along with excellent service to the policyholders and campaign among the people.

For the last 61 years LIC served the nation and its people. Today it stands as a colossus in the financial firmament of the country. In a mos t unhealthy economic environment and a prejudiced regulatory regime, LIC has to maintain its growth, protect its market share and meet the ever increasing customer expectations. LIC has a very purposeful existence and it has the enormous goodwill of the people of the country. LIC serves the largest number of policies in the world and has highest number of committed and active agents. LIC has committed workforce in all cadres and this will put it in good stead in facing the future challenges and onslaughts of the neoliberal agenda. The cadres of AIIEA will continue to protect the light that illuminated millions of lives across the country for the last 61 years. It is a commitment that AIIEA gives to the nation on the occasion of the 62<sup>nd</sup> foundation day of LIC.

he GIC: Re filed its draft red herring prospectus to the SEBI on August 7, 2017 for public listing. The New India Assurance Co. ltd. followed suit on August 9, 2017. The public offer will result in dilution of 14.22% and 14.56% stake of the Government in the post issue share capital of the GIC:Re and the New India respectively. As declared by both the companies, the net proceeds on issue of fresh shares would be utilized for meeting the capital needs of the companies during expansion of their businesses and augmenting the solvency margin. Another objective for filing for listing, as declared in the prospectus is enhancement of the brand value of these companies. Above all, the proceeds on the sale of shares of the Government would be retained by the Government itself.

A closer look at the Financial position of the GIC: Re and The New India would make it clear that capital infusion as the reason being put forward by these companies for listing in the stock market, is unconvincing, to say the least. For instance, The New India with a net worth (including fair value of investments) of Rs. 34,716 crore, Asset base of Rs.69173 crore and a solvency margin of 2.16 is well placed to meet any future capital requirement from its own resources. The solvency margin for GIC-Re is even more at 3.46. As far as building of brand value is concerned, it is our experience that it has no connection with listing in the Stock Market. The brightest example of the same is LIC of India. Further, it would be worth mentioning here that the National Insurance Company Limited, a PSGI Company, issued subordinated debt bonds to improve its solvency margin which was 1.26. As per the market reports, the response of the investors was overwhelming. Such is the brand image of any PSGI Company that it can attract a large number of investors even if it needs debt to strengthen its financial position. Hence, it is evident that the afore stated reasons, being put forth by the companies, are being used to distract us from the fact that the Government is withdrawing itself from few more marvelously performing public sector companies and making space for the entry of private capital in these companies. Moreover, this is just a beginning, as other three PSGI Companies viz. National Insurance, United India Insurance and Oriental Insurance are also gearing themselves up to hit the market.

It is common knowledge that in January,

2017, the Central cabinet had already approved dilution of its stake by 25% in the PSGI Companies. Subsequently, the Central budget for the year 2017-18 set a target of collecting Rs. 72500 Crore through disinvestment and outright sale of Public Sector Enterprises in order to keep the Fiscal Deficit at 3.2% of the GDP. The government set a target of raising Rs.11000 crore through disinvestment of shares in the PSGI companies and GIC-Re. This is also evident that the present Government, with its avowed objective of working as a facilitator for the private big corporate, will have a clear agenda to weaken the Public Sector Units, which work as bulwark against the predatory movement of the private capital. To achieve this objective, billions are foregone in the name of tax incentives to big corporates and then the fiscal deficit is controlled by curtailing the allocations on the welfare schemes and selling off the shares of Public sector Undertakings. The same exercise is being undertaken now by involving the PSGI Companies. However, the PSGI Companies are not alone in their scheme of things. The Niti Aayog has already listed out 74 PSUs for disinvestment.

The AIIEA is committed towards strengthening of PSGI Companies. Hence, even a minute dilution of the Public Sector Character is not acceptable to us. This is not a mere rhetoric based on some ideology only. This stand of ours is based on strong economic considerations keeping in mind the betterment of the majority of the people. The

PSGI Companies were formed to fulfill three specific objectives viz. 1) To make general insurance services available to the vast majority of the people, 2) To give insurance facilities at an affordable price and 3)To introduce professionalism in the market. If we look into the 46 years' performance of the PSGI Companies, we can rightly claim that these companies have done exceedingly well on all the three parameters stated above. With their approximately 8500 offices spread over 608 districts of the country, these Insurance Companies have their offices in tier IV cities also. They have been in the forefront, when it comes to the implementation of welfare schemes of the Government. The latest instances are PMSBY and PMFBY. The four PSGI Companies are way ahead of others in making these two schemes successful. It is pertinent to mention that the overwhelming number of policies under Pradhan Mantri Suraksha Bima Yojana are being underwriting by the public sector companies. The annual premium of Rs.12 is not sufficient to meet the cost of the claims. The claim experience is more than 170 percent. This means that for every 100 rupee of premium, the companies are paying claims worth Rs.170/-. The government is not underwriting this loss. Despite meeting the social obligations as their prime functions, these PSGI Companies have not compromised on professionalism. This is why, even after facing competition (sometimes unethical) from a number of Private Insurers, the PSGI Companies are still holding 52% of market

share with the four PSGI Companies placed at first four positions till the Financial year 2016-17. The above facts are sufficient to drive home, why AIIEA stands for strong PSGI Companies. Also, from our experience with disinvestment in other sectors we apprehend that even a minute infusion of private capital would result into shifting of the accountability of these companies from policyholders and common people to the private shareholders, whose sole motive would be to maximize their profits. This is not acceptable to us. Hence, we are against the efforts being made by the Companies for listing in the Stock Market.

AIIEA has successfully fought against privatization of Public Sector General Insurance Companies for more than 23 years. We have already been campaigning against the efforts of disinvestment through mass campaigns, conventions etc. We have also forged a broader unity among other Associations of Employees and Officers in the industry. After the first phase of the joint struggle programme, the next phase is going to commence from August 22, 2017. The campaign has to gain greater momentum. It must focus not just on mobilizing employees to fight these disastrous policies but also to win the support of all progressive sections of the Indian population in favour of our struggle. The AIIEA, as always would play an active and leading role in the struggle. We know that challenge before us is enormous. But we believe, we can overcome.

### SIGNATURE CAMPAIGN AGAINST GST ON INSUSRANCE PREMIUM Scintillating Performance

he decision of the AIIEA Working Committee to mobilize the policyholders and general public against imposition of GST on insurance premium has evoked massive response across the country. The SZIEF stands out with a magnificent performance. According to the information received, so far more than 10 lakh signatures have been collected in South Zone. Thanjavur Division has done an excellent job by collecting over 2 lakh signatures. Madurai, Salem and Tiruvananthapuram Division would have crossed 1 lakh signatures by the time this issue goes to the press. All other divisions of South Zone are expected to collect the targeted 1 lakh signatures before 31st August 2017.

The signature collection momentum has picked up in the South Central Zone. There are enthusiastic reports from across the country. Insurance Worker will bring out a detailed report with photographs in the October issue on this program. However, some details of the campaign carried out by the Tamilnadu and Kerala Units is necessary to be mentioned to place on record the great done by the employees.

The units of SZIEF began the campaign by collecting signatures from eminent personalities spread across the zone. But this campaign also met with resistance from the organizations owing allegiance to the BJP. In Vellore when our Comrades were collecting signatures at the DKM Arts College, those belonging to ABVP objected to it. In spite of their objection, our Comrades campaigned among the students and the staff and got signatures. In another incident at Veeravanallur, near Cheranmadhevi Branch (Tirunelveli Division) when a large number of our Women Comrades were collecting signatures among the public, the cadres of BJP objected to our campaign. They asked us to stop the campaign immediately. When our Comrades proceeded with the campaign in spite of their resistance, they even sought police intervention. But they could not succeed in both the places since public response to our campaign was overwhelming. The government has been spending much on the advertisements explaining that the GST would be beneficial to the masses. But they do not tolerate the movements like these which expose the burdens laden with the GST.

In many places Street Corner meetings involving our cadres and fraternal organizations were conducted. Pamphlets were distributed among the public utilizing these opportunities. The policyholders who are burdened with higher taxes have overwhelmingly in support of this campaign.

he International Day of Peace is observed around the world on 21stSeptember of every year. This day was declared by the United Nations General Assembly as a day devoted to strengthen the ideals of peace, both within and among all nations and people. This day is celebrated to recognize the efforts of those who have worked hard to end conflicts and promote peace. To inaugurate the day, the United Nations Peace Bell is rung at UN Headquarters. The bell is cast from coins donated by children from all continents except Africa, and was a gift from the United Nations Association of Japan as "a reminder of the human cost of war". The inscription on its side reads, "Long live absolute world peace". The Day embodies our shared aspiration to end the needless suffering caused by armed conflict. Yet, there is more to achieve peace than laying down weapons. True, peace requires building bridges between the people, combating discrimination and standing up for the human rights of all the people of the world.

The theme for the International Day of Peace this year is: "Together for Peace: Respect, Safety and Dignity for All". The theme is focusing in particular on the plight of refugees and migrants throughout the world. While observing the day on this theme, it is our obligation to ensure that everyone who are forced to flee their homes in search of a better life receives the protection to which they are entitled to under the international law. It is our duty to replace fear with kindness.



#### World - Less Peaceful

The 10<sup>th</sup> Annual Global Peace Index (GPI) shows that we are now further away from world peace than at any time in the past 10 years and it is creating a global 'peace inequality gap. The 2017 Global Peace Index shows that amidst continuing social and political turmoil, the world continues to spend enormous resources on creating and containing violence, but very little on peace. The index finds that globally the economic impact of violence on the economy is enormous. The world is becoming a more dangerous place and there are now just 10 countries which can be considered completely free from conflict. Iceland remains the most peaceful country in the world, followed by New Zealand, Portugal, Austria and Denmark. Syria remains the least peaceful country in the world followed by Afghanistan, Iraq, South Sudan and Yemen. The worsening conflict in the Middle East, the lack of solution to the refugee crisis and an increase in the incidence of deaths from major terrorist attacks have all contributed to the world being less peaceful in 2016 than it was in 2015. The conflicts in Afghanistan and Iraq have been going on for well over a decade. Then it spilled into Syria in 2011, and afterwards into Libya and Yemen. If we take battlefield deaths, they are up at 1,12,000 – a 20 year high. And 75% of these deaths are in Syria, Iraq and Afghanistan. The 10 year trend in peacefulness finds that global peacefulness has deteriorated by 2.14% since 2008. According to GPI, 52% of countries have recorded deterioration, while 48% have improved. The global level of peacefulness deteriorated rapidly after the global financial crisis.

The largest regional deteriorations in the score occurred in North America, followed by Sub-Saharan Africa and the Middle East and North Africa. The score for North America deteriorated entirely as a result of the US, which more than offset a mild improvement in Canada. The score of US has been dragged down largely because of deterioration in several indicators, i.e., homicide rate, level of perceived criminality in society and the intensity of organized internal conflict. The latter measure has deteriorated because of the increased levels of political polarization within the US political system. Though Europe remains the most peaceful region in the world, the average peace score did not change notably due to the substantial deterioration in Turkey, the impact of the terrorist attacks in Belgium and France, etc.

#### Imperialist aggression in the world

The falling trend in the global peacefulness is a matter of concern for all peace loving people. At the same time, if we look at the things happening around the world, we fear that in GPI 2018, the world would become a still more dangerous place to live. War comes at a cost, not only in terms of the devastation and disruption it causes, but also the economic, social and political costs that accompany such wars. After Trump assumed the Presidency, the US launched military attacks on Syria on the pretext of use of chemical weapons by Syria. Already, the air-strikes of US under the watch of Donald Trump have killed innocent civilians at a much higher rate than under Obama, with horrifying numbers of people killed in Syria and Iraq. Three years after Obama officially declared US exit from Afghanistan, the US military dropped Americas powerful nonnuclear bomb - 'the mother of all bombs on ISIS targets in Afghanistan. Trump is claiming that it was his call to end financial support to terrorist groups. And this has led to Saudi Arabia, Bahrain, the United Arab Emirates and Egypt isolating Qatar by accusing that it is funding terrorist groups. But, the real reason is that Qatar is being punished for not toeing the US line on Iran. The victory of Trump has emboldened the Israeli government. On the pretext of fighting terrorists, it has mounted air strikes on Syria. Israel is also building more colonies in Palestine. Recently, President of US has warned North Korea that the US military is "locked and loaded". Trump has stated that it would be the best for North Korea not to make any more threats to the US. If not, then they will be met with fire and fury like the world has never seen. US imperialism is also intensifying its attempts to regain its control over Latin America.

#### **Communal offensive in India**

While Bhutan (13<sup>th</sup> rank) is the most peaceful country in South Asia, India ranks 137<sup>th</sup> in Global Peace Index 2017. The victory of BJP in 2014 general elections for Lok Sabha and in some of the State Assembly elections has emboldened the rightwing outfits to pursue communal divisive agenda more violently with the active support of the administration at the Centre and in many States. In the recent period, the attacks on Dalits and minorities by the cow vigilante groups have increased in many States, particularly where the BJP government is in power. Despite sporadic protests across the nation, cow vigilantism is continuing unabated. The rise in violence against Muslims across the country by the socalled 'gau rakshas is full of dire portent. The intolerance has increased which has resulted in ruining the peace of the nation. The rulers at the Centre, and in some States – especially the BJP run – instead of dousing the fire of hatred killings etc in the name of caste and religion, fuel it. If we want to ensure respect, safety and dignity to all the people living in India, then the religious fundamentalism – both majority and minority - needs to be contained. The people of the country should uphold the tradition of celebrating the idea of India – unity in diversity.

The failures on the economic front have no less contribution to the ills of the Indian society. Promises doled out by the PM on creation of jobs have been thrown to the four winds. It is the despondent and hapless youth that fall an easy prey to casteism and communalism of all hues. Let us not forget here that it is such disgruntled youth that are swayed by the racist movement even in the advanced countries in the West including US.

There have been a procession of hollow slogans in India like, "Ache Din", "Swach

Bharat", "Smart cities", "Make in India", "Stand up India", "Start up India", "Digital India" – the latest being "New India". But no slogan ever came to be implemented seriously. The pent-up feelings of disappointment and despair would naturally lead to actions that dent the peace and tranquility of the Indian society.

#### Need of the hour

Peace needs not only to be firmly established as being a desirable value and state of being, but also must be something that has an active tangible relationship and emotional bond with humankind. For this, the value and wider positive effects of peace must be instilled into each and every person. According to this years International Peace Day theme, people should not only have the ability, but also the right to enjoy peace.

On this International Peace Day of 2017, let us remember that millions of vulnerable members of our society, many of whom have lost everything, need our understanding and assistance. Let us work out together about what we can do to help them. And let us redouble our efforts to address the root causes of conflict, advance our activities towards growth for all and heighten our emphasis on preventing violence in the first place. By opening our hearts, joining our hands and reaching out to refugees and migrants, let us move closer to attaining peace, prosperity and protection for all.

### **Dissent is Not Treason... It is the Essence of Democracy'** Military Veterans to Modi

A group of 114 veterans of the Indian Armed Forces have written an open letter to the prime minister, chief ministers of states and lieutenant-governors of union territories, expressing their distress at "divisive" recent developments in the country which "go against the secular and democratic values enshrined in the constitution". The letter is reproduced below. WE are a group of veterans of the Indian Armed Forces who have spent our careers working for the security of our country. Collectively, our group holds no affiliation with any single political party, our only common commitment being to the constitution of India.

It saddens us to write this letter, but current events in India have compelled us to register our dismay at the divisiveness that is gripping our country. We stand with the 'Not in My Name' campaign that mobilised thousands of citizens across the country to protest against the current climate of fear, intimidation, hate and suspicion.

The armed forces stand for "unity in diversity". Differences in religion, language, caste, culture or any other marker of belonging have not mattered to the cohesion of the armed forces, and servicemen of different backgrounds have fought shoulder to shoulder in the defence of our nation, as they continue to do today. Throughout our service, a sense of openness, justice and fair play guided our actions. We are one family. Our heritage is like the multi-coloured quilt that is India, and we cherish this vibrant diversity.

However, what is happening in our country today strikes at all that the armed forces, and indeed our constitution, stand for. We are witness to unprecedented attacks on society at large by the relentless vigilantism of self-appointed protectors of Hinduism. We condemn the targeting of Muslims and Dalits. We condemn the clampdowns on free speech by attacks on media outlets, civil society groups, universities, journalists and scholars, through a campaign of branding them antinational and unleashing violence against them while the state looks away.

We can no longer look away. We would be doing a disservice to our country if we do not stand up and speak for the liberal and secular values that our constitution espouses. Our diversity is our greatest strength. Dissent is not treason; in fact, it is the essence of democracy.

We urge the powers that be at the centre and in the states to take note of our concerns and urgently act to uphold our constitution, both in letter and in spirit.

प्रधानमंत्री नरेन्द्र मोदी के विदेशी दौरों की गोदी मीडिया में धूम ही धूम। चौथी–पांचवी बार अमेरीकी यात्रा। फस्ट लेडी मेलानिया से गर्मजोषी पूर्ण हाथ मिलाई। सच्चे मित्र डोनाल्ड टूंप से गलबहियां कर पायी शाबासी की थपकियां और व्हाईट हाउस में दावत। संयुक्त बयान में आंतकवाद पर कड़ा प्रहार। 100 हवाई जहाज और 22 ड्रोनों की खरीददारी की कीमत चुकाई के बाद कारोबारियों के साथ इवांका और ट्रंप परिवार को भारत दर्शन का आमंत्रण। न एच.1बी.1 वीजा पर बात न पेरिस जलवायु समझौते से पीछे हटे ट्रंप से कोई शिकायत। गलबहियां और बी.1 'सच्चे मित्र' के विश्लेषण से आगे और चाहिए भी क्या भला? सच्चे मित्र से गले मिलने की सुर्खियां बनी हुई थी कि एक और सुर्खी दूसरे नेचुरल मित्र नीदरलैंड के प्रधानमंत्री मार्क रूट से मिलने की उभर आई। नीदरलैंड के एक सप्ताह बाद सदियों पुराने फिलस्तीनी संबंधों को तिलांजली दे जा पहुंचे एक और असली मित्र नेतन्याहू से मिलने इजराइल के तेल अवीव।

विदेशी दौरे और प्रचार की भुख, दोनों ही ऐसी चीजें हैं जो 'बीमारी बढ़ती गई, ज्यों ज्यों दवा की' भांति बढ़ती ही जा रही हैं। नरेन्द्र मोदी की अब तक 56 देशों की विदशी यात्राओं का हासिल क्या है? दुर देशों की बात तो छोड़ो, आज हमारा एक भी पड़ोसी ऐसा नहीं है जो हमसे स्नेह रखता हो। क्या बड़बोलापन इसकी जड़ में है? संबंध हेकड़ी से नहीं, सद्धावपूर्ण पारस्परिकता से बनते हैं। कारोबारी संबंधों की एक सीमा है। बड़बोलेपन की सुपरस्टार मोदी सरकार ट्रंप के गले क्या मिले. उनके वित्तमंत्री अरूण जेटली ने तेस में आकर कह दिया कि चीन भारत को 1962 का भारत नहीं समझे। जवाब में चीन ने भी कह दिया कि भारत भी चीन को 1962 वाला चीन न समझे। बात भी सही है कि आज दुनिया में एक-आध देश को छोड़कर कोई भी 55 वर्ष पीछें की स्थिति में नहीं है और भारत भी कोई 3 साल में बदल गया है, ऐसा भी नहीं है। लेकिन फटीगृदड़ी की सोच लिये संघी सरकार को प्रगतिशीलता नजर आती ही कहां है? अगर दिखती होती तो गुटनिरपेक्ष आंदोलन में हमारी बनी विश्वनेता की छवि को तोड़कर प्रधानमंत्री नरेन्द्र मोदी अपना अगला दौरा इजराइल का क्यों करते? होने को फिर वही हथियारों का सौदा और अपने जरखरीद पीठू मीडिया के सहारे एक और 'असली दोस्त' का प्रचारा अब ये मत पछिये ऐसे सच्चे, नेचुरल और असली मित्र और कितने हैं। अगर गिनाने लगे तो मेमोरी कार्ड और प्रिन्टर भार नहीं झेल पायेंगे। इसलिए मित्रों की बात छोड़ हम मीडिया की कही बातों की ही थोड़ी खबर लें कि वे हमारे प्रधानमंत्री के अमेरीकी दौरे को किस नजर से देखते हैं।

न्यूयार्क टाइम्स अखबार ने एक आला अधिकारी के हवाले से लिखा है कि दोनों नेताओं की आत्मीयता चीनी राष्ट्रपति शी जिनपिंग को दिखाने के लिए थी। क्योंकि ट्रंप चीन से काफी नाराज है। उत्तर कोरिया के मिसाइल कार्यक्रम को रोकने में वे विफल रहे हैं। ट्रंप सरकार भारत को 22 ड्रोन बेच रही है। इसका इस्तेमाल भारत हिंद महासागर में चीन की जासूसी करने में कर सकता है। उधर, चीन के प्रति भारत का संदेह गहरा है। शी जिनपिंग के महत्वाकांक्षी प्रोजेक्ट ओ.बी.ओ.आर. पर भारत को कई आपत्तियां हैं। ऐसे में मोदी चीन से होड़ के लिए ट्रंप की तरफदारी चाहते हैं।

वहीं ग्लोबल टाइम्स अखबार ने अमेरिकी थिंकटैंक अटलांटिक काउंसिल के दस्तावेज के हवाले से लिखा है कि 'बीजिंग का बढ़ता प्रभाव रोकने के लिए वाषिंगटन को नई दिल्ली की जरूरत होगी। इसमें भारत के लिए गर्व करने लायक कुछ भी नहीं है। अखबार ने आगे लिखा है कि अमेरिका और भारत, चीन के उदय पर चिंता साझा करते हैं। अमेरिका ने चीन पर दबाव डालने के लिए भारत से दोस्ती बढ़ाई है। चीन को घेरने की अमेरीकी रणनीति का हिस्सा बनना भारत के हित में नहीं है। इसके विनाशकारी परिणाम भी हो सकते हैं। अखबार ने लिखा कि चीन के साथ मजबूती से खड़े रहना भारत के लिए मददगार होगा।'

वॉषिंगटन पोस्ट ने लिखा कि पत्रकारों को मुलकात से पहले ही बता दिया गया था कि कोई भी प्ररुन नहीं लिया जायगा। पेरिस समझौते पर कोई बात नहीं हुई। डॉन ने लिखा कि मोदी और ट्रंप ने एक-दूसरे को दोस्त की तरह गले लगाया। ट्रंप ने पाकिस्तान से यह सुनिश्चित करने को कहा कि उसकी जमीन से आंतकवाद न पनपे। लेकिन पाकिस्तान ने तुरन्त बयान देकर कह दिया कि कश्मीर को आंतक से न जोड़ें। द इंडिपेंडेंट ने लिखा कि विश्व नेताओं के साथ ट्रंप की मुलाकात सौदों के इर्द-गिर्द होती है। भारत के साथ भी सैन्य सहयोग पर बात हुई और रक्षा सौदे हुए। इसके एक सप्ताह बाद इजराइल की यात्रा पर गये मोदी और उसका गोदी मोडिया दोनों ही नेतन्याहू द्वारा किये गये स्वागत से अभिभूत हो गये।

एक तरफ नेतन्याहू मोदी के जरिये दुनिया को यह संदेश देना चाहते हैं कि इजराइल की स्वीकार्यता बढ़ रही है तो वहीं मोदी भी पहले नोटबंदी, किसान आंदोलन और अब जी.एस.टी. से पिट रही भद से ध्यान हटाने का उपक्रम कर रहे हैं। इजराइल से भारत के संबंध 25 साल पहले शुरू हुए। 25 साल पहले 1295 रू. का शुरूआती व्यापार अब 32000 करोड़ रू. के कारोबार में बदल गया है। रूस और अमेरिका के बाद इजराइल हमारा सबसे बडा. हथियार निर्यातक दश है। इजरायल सबसे ज्यादा हथियार भारत को बेचता है। यानि कुल निर्यात का लगभग 40 प्रतिशत। बीते 3 सालों में दोनों देषों के बीच 26000 करोड़ रू. के रक्षा सौदे हए। अभी 13000 करोड़ रू. के हथियारों की डील जिसमें 10 हेरोन टोपी ड्रोन को लेकर 2590 करोड़ रू. एवं स्पाइक मिसाइल को लेकर 3237 करोड़ रू. का सौदा इस यात्रा का फलित है। नारा 'मेक इन इंडिया' विदेशी निवेश को आंमत्रण और हर दौरे में हथियारों के सौदे। हैं न गजब का स्वदेशी जागरण और

देशभकी। जर्मनी और फ्रांस गये तो वहां रॉफेल हेलिकाफ्टर और होवित्सर तोप का सौदा कर आये तो अब ये हथियार सौदे। समझ सकते हैं, कितनी कीमती हैं मोदीजी की ये विदेशी यात्राएं। दलाली ना बाबा ना। मोदीजी के शासन में काननी जो हो गई है।

भले ही विदेश मंत्री सुषमा स्वराज ने संसद में सवालों से धिरने पर बातचीत के महत्व को स्वीकारा हो परन्त हकीकत यह है कि नरेन्द्र मोदी की सरकार जब से बनी है तब से उसकी घरेलू नीति का असर विदेश नीति पर परिलक्षित हो रहा है। यह सरकार दिखावटी तौर विदशी दौरे चाहे जितने कर रही हो परन्तु व्यवहार में वह हमारी शांति, सहअस्तित्व और गुटनिरेपक्षता की नीति को पलटकर टकराव के रास्ते पर जा रही है। वह अपने ऐतिहासिक और विरासती स्थायी मैत्रैयी संबंधों को तिलाजंली देते हए उन साम्राज्यवादी शक्तियों की पिछलग्ग बनकर इतरा रही है। जिनका एजेन्डा ही युद्ध और कारोबार के जरिये अपने साम्राज्य और आर्थिक हितों को विस्तार देना रहा है। परिणामस्वरूप हमारे पड़ोसियों से टकराव का परिवश बन रहा है। जिन मुद्दों को बातचीत से आसानी से हल किया जा सकता है, उन पर मोदी सरकार के हेकड़ी भरे बयान तनाव बढ़ा रहे हैं।

जहां बातचीत फासले और गलतफहमियों को दूर करता हैं वहीं टकराव फासले को और गहरा करता है। मोदी सरकार के हिन्दुत्ववादी रूझान हमारी विदेश नीति के मूलभूत सिद्धान्तों को पलट रहे हैं। जब तब राष्ट्रवाद के तड़के, 56 इंची सीने का बड़बोलापन और परमाणु शक्ति सम्पन्न राष्ट्रों के बीच युद्ध के परिवश के निर्माण में न तो कोई समझदारी है और न ही यह राजनयन की गंभीरता और कौसल को दिखाता है। विदेश नीति से यू टर्न लेना हमारे राष्ट्रीय हित के विपरीत है। शांति और विश्व भ्रातृत्व की हमारी विदश नीति से विपरीत दिशा में जाकर हम देशों के समूह के बीच स्थापित अपना स्थान खो रहे हैं। गुटनिरपेक्ष आंदोलन की अगुवाई कर हमने जो असम्बद्धता की विष्व छवि बनाई थी, वो अमेरिका–इजरायल से सम्बद्धता दिखाकर खो रहे हैं।

At a time when neoliberalism undermines democracy, throws millions of workers out of jobs, when dictators masquerade as champions of democracy, when the far right and neo-Nazis have risen their ugly heads and when the American imperialism seeks to expand the empire by war...



# Commemorating Charlie Chaplin, the People's Artist

Christmas Day this year shall mark the 40<sup>th</sup> death anniversary of Charles Spencer Chaplin, popularly known as Charlie Chaplin, who won over the hearts of millions of cinema-audiences across the world through his unique style of acting on the big screen. No one else acting in motion picture could equal his feat till date. Just a few hours before his family's traditional Christmas celebration was to begin, Charlie Chaplin died at 4 a.m. on 25 December, 1977 at his home at Corsier-sur-Vevey, a small village near the eastern end of the Lake of Geneva, Switzerland. At the time of his death his wife Oona and seven of their children were at the bedside.

Charlie Chaplin was born on the night of 16 April 1889 in East Street, Walworth, London. At that time Sydney, his half-brother, was four years old. His father, Charles Chaplin, Sr., and mother, Hannah Chaplin (Hill), separated even before Charlie was three. Both of them were music hall performers. Chaplin, Sr., deserted the family to go on tour. He died of alcoholism in 1901, at the age of 37. Charlie and his half-brother Sydney became accustomed to fend for themselves. Chaplin's childhood, in fact, reminds one of that of a Charles Dickens character. According to Jerome Larcher, a producer and script-writer and former editor of Cahiers du cinema: "It constitutes the matrix of his cinematic world; in a sense, his tramp character represents an imaginary extension of the boy he once was".

It was his mother who passed on the theatrical baton to Charlie Chaplin. He made his first appearance on the stage just at the

age of 5 when his mother's voice cracked while performing and she was booed off the stage. Charlie later recalled in his autobiography: "The audience began to laugh and sing falsetto and to make catcalls. It was all vague and I did not guite understand what was going on. But the noise increased until Mother was obliged to walk off the stage". At that stage the stage manager, who had seen him perform before his mother's friends, led him by his hand to the stage and left him there alone after placing some explanatory words to the audience. Charlie's performance enthralled the audience and they greeted him by loud applause. His suffering did not end here. The family of mother and two sons sank further in poverty. Hannah and the two children were compelled to enter the Lambeth workhouse. Subsequently, Charlie and Sydney were dispatched to an orphanage outside London. Here a huge warden unjustly caned him. Perhaps, this is why, a critic say, we see the puny tramp's (the tramp character he portrayed) future defiance towards not only oversized men but also all forms of authority.

Charlie Chaplin's life gradually rebounded from adversity. His clog dancing did not continue for long. This brief period was followed by what a correspondent of The New York Times called "weeks and months of catch-as-catch-can existence". He took on a series of odd jobs news vendor, barber's assistant, printer, toy maker etc. Charlie reminisced later, "...., but during these occupational digressions, I never lost sight of my ultimate aim to become an actor". At the age of 12, his perseverance was rewarded. He received the role of Billy the Groom in William Gillette's play "Sherlock Homes" and toured the provinces. It was at

that time he began to make a name for himself.

He left the world of the theatre in 1906 and

switched to pantomime. He stepped into the

world of cinema when, in 1913, Mack Sennett,

then the producer of short film comedies

spotted him. He joined Sennett in Los Angeles

and made his first appearance in "Making a

Living" in 1914. The film was a one-reeler.

It was at Mack Sennett's Keystone studios in

early 1914 Charlie created the tramp character

while the shooting of the film "Mabel's Strange

Predicament" was on. The character dressed

in baggy pants, big shoes, a cane and a derby

hat. He recollected later, "I wanted everything

a contradiction: the pants baggy, the coat tight, the hat small and shoes large". The

character was an instant hit with the cinema-

goers. Charlie's association with Mack Sennett

lasted for one year during which he acted in 35

films. His fame enabled him to join the Essanay

Company and worked in 14 films in 1915, including "The Tramp". Film critics say that

the movie was his first generally recognized classic and first in which he introduced a note

of pathos. In 1917, Charlie Chaplin built his

own studio in the heart of Hollywood. For the first time he became his own producer in his

own studio. He co-founded United Artists, the distribution company, in 1919. This gave

him complete control over his films. His first

feature-film was "The Kid"(1921). His role in

the film was not only as an actor; he was the

writer, director and producer of the film. Charlie Chaplin's masterpiece "The Kid", according to

a film critic, was 'a chapter out of Chaplin's

own slum life'. It is widely acknowledged that

Charlie Chaplin, a stickler for perfection, helped

elevate film to a respected art form. The man

was also a great music composer. Beginning

with "City Lights" (1931), he composed music

for his films. Despite Charlie's fortune and

fame, he never forgot his days of poverty

and the struggle for existence. He also did

not neglect his mother and saw to it that she

where she died on 28 August 1928. Charlie Chaplin's films contained social and political themes. During his lifetime many significant events took place. The first world war, the Russian revolution, the growing unemployment in America, the Great Depression, the rise of fascism in Europe, the second world war, McCarthyism in the United States— all these impacted his creative genius. The silent era tramp character was an icon of a poor man in modern capitalist society. Chaplin was concerned about the devastating effects of the Great Depression. His fear was that capitalism, along with the use of machinery at the workplace, would just increase unemployment. This concern gave birth to "Modern Times" (1936). The film, partly, is a comic commentary on the dehumanized aspects of the mechanized, industrial world. Charlie Chaplin was known to have sympathies for the Left from 1920 onwards, reminds Vijay Prashad in his article, "The Political Life and Cinema of Comrade Charlie Chaplin"(The Wire, 29.07.2017). The readers shall find it interesting to learn what Charlie had told Buster Keaton — the famous actor of silent movies—on communism. According to Keaton, Charlie stated: "Communism was going to change everything, abolish poverty". Then he banged on the table and said, "What I want is that every child should have enough to eat, shoes on his feet and a roof over his head". (Ibid) In the backdrop of the rise of fascism in Europe, Charlie Chaplin wrote the script of "The Great Dictator" in 1938. He started shooting the film in the following year. In 1940, the world premiere of "The Great Dictator" was held in New York. "A ferocious ridicule of Hitler and Mussolini, the film has grown in stature over the years as its political implications have been, according to critics, more fully realized". This was what Bosley Crowther wrote in The New York Times on December 26, 1977 while paying a rich tribute to Charlie Chaplin. Charlie later wrote in his autobiography:"Although The Great Dictator was extremely popular with the American public, it no doubt created underground antagonism". Adverse publicity against him started appearing in the Press. Despite that, "The Great Dictator", according to the creator himself, continued breaking records both in England and America. Charlie Chaplin's denouncement of fascism did not stop with the creation of "The Great Dictator". When the gruesome Nazi invasion of USSR was on, Charlie Chaplin became very much vocal in support of the Soviet Union and tried to build up public opinion in America in favour of opening a second front immediately. In 1942,

he received a telephone call from the head of the American Committee for Russian war relief in San Francisco, asking him if he would take the place of Mr. Joseph E. Davies, the American Ambassador to Russia, who was to speak, but at the last moment had been attacked with laryngitis. Charlie Chaplin accepted the invitation. The following day



the meeting was held. The hall became packed with ten thousand people. He addressed the audience with the word, "Comrades". He continued emphatically: "And I mean comrades, I assume there are many Russians here tonight, and the way your countrymen are fighting and dying at this very moment, it is an honour and a privilege to call you comrades". (My Autobiography: Charles Chaplin). Just a few weeks later a huge rally for a second front was held in Madison Square Park, New York. The sponsors of the mass meeting held on July 22, 1942 were 250 unions affiliated with the Greater New York Industrial Union Council, C.I.O. Sixty thousand people attended the rally. Charlie had been requested by the organisers to address the meeting via telephone. He made a significant beginning: "On the battlefields of Russia democracy will live or die. The fate of the Allied nations is in the hands of Communists. If Russia is defeated the Asiatic continent -the largest and richest of this globe-would be under the domination of the Nazis".

The releases of "Modern Times" and "The Great Dictator", his passionate speeches calling for the opening of a second front in Europe and his pro-Communist leaning, though he himself declared that he was not a Communist, brought serious troubles for him in his adopted country, America. His broken marriages and his love life also gave his critics the opportunity to blacken his reputation. Nevertheless, Charlie Chaplin, the people's artist of America, was hounded by the American rulers mainly because he was suspected as a Communist. Charlie Chaplin was subpoenaed to appear before the House Committee on Un-American Activities in June 1947(eventually postponed). He released a press statement inviting the committee members to watch "Monsieur Verdoux" with



close attention:"It is against war and the futile slaughter of our youth. I trust you will not find its human message distasteful....." Charlie Chaplin was virtually exiled by the authorities of the United States. In September 1952, he was sailing to London, accompanied by Oona and their children. The captain of the ship was

informed that Charlie Chaplin's re-entry permit had been revoked. Offended, he spent the rest of his life in Europe, settling on an estate at Vevey, Switzerland.

At a time when neoliberalism undermines democracy, throws millions of workers out of jobs, when dictators masquerade as champions of democracy, when the far right and neo-Nazis have risen their ugly heads and when the American imperialism seeks to expand the empire by war, the following words of Charlie Chaplin's speech in "The Great Dictator" keep ringing:

"In the 17<sup>th</sup> chapter of St Luke it is written: 'the kingdom of God is within man'—not one man nor a group of men, but in all men! In you! You, the people have the power—the power to create machines. The power to create happiness! You, the people, have the power to make this life free and beautiful, to make this life a wonderful adventure.

Then— in the name of democracy—let us use that power— let us all unite. Let us fight for a new world— a decent world that will give men a chance to work— that will give youth a future and old age a security. By the promise of these things, brutes have risen to power. But they lie! They do not fulfil that promise. They never will.

Dictators free themselves but they enslave the people! Now let us fight to fulfil that promise! Let us fight to free the world— to do away with national barriers— to do away with greed, with hate and intolerance. Let us fight for a world of reason, a world where science and progress will lead to all men's happiness. Soldiers! In the name of democracy, let us all unite!"

### **International Conference on Global Insurance Practices**

he Department of Commerce, Osmania University, Hyderabad has organized a three day International Conference on "Global Insurance: Practices and Outlook" from 29<sup>th</sup> – 31<sup>st</sup> July 2017, in the Platinum Jubilee Conference Hall of PGRRCDE, OU Campus. The Conference was organized in collaboration with Telangana State Council for Higher Education and as a part of the ongoing Centenary Year Celebrations of Osmania University. The conference is aimed at 'bringing together all the stake holder to share their views and thoughts on the direction to penetrate the insurance sector further and to develop the new curriculum for graduate and post graduates, who can build their career in insurance sector.' Delegates from different



countries have attended the conference and made it successful. It is a matter of proud privilege that Com. K Venu Gopal, Vice-President, AIIEA and Com. V Ramesh, General Secretary, AIIEA were special invitees to the conference as speakers.

Com. K Venu Gopal addressed the conference in the forenoon session, on 29.07.2017. He congratulated the organizers for their effort to introduce a comprehensive course on Insurance, as a subject in the curriculum. Insurance is a promise to accept the risk, which is dependent on a contingency. Fulfilling this promise with integrity, through prompt Servicing and Claim settlement, is the Hallmark of Insurance, he said. In spite of 24 Private Insurance Companies operating in the Life Sector, LIC could retain 74 % Market Share and the Claim Settlement ratio is 99.86. Insurance is a means of mobilizing People's small savings and providing social security in return. People's savings should

always be protected. These small savings, so mobilized, will form a huge investment for the nation building and social welfare activities. Underwriting is a key aspect of Insurance and adverse selection of life should be avoided at all costs. The role of the Regulator is also of utmost importance in the Insurance Business, he said. He advised the students to focus study on these aspects, while undergoing the course.

Com. V Ramesh, while addressing the conference, informed that in the prevailing stagnant world economic scenario, the purchasing power of the common man is severely affected and this in turn is adversely affecting the Insurance Business, world over. But, even in such adverse situation, penetration of Insurance esp., Life Insurance

is 2.6% in India, which is more than that of many advanced countries, he said. Though the Government promised the inflow of \$ 25 billion FDI in to Insurance Market, at the time of opening up of Insurance to private capital in 1999, only Rs 8000 crore investment came so far, as per IRDA reports, he informed. Jobless Growth is prevalent in the country. Contractualisation of labour and rampant unemployment

are contributing for the slow progress in insurance penetration, he opined. It is unfortunate that the government, instead of supporting the Industry by giving incentives in the form of enhanced tax concessions, is heaping further burden on policy holders by increasing GST on Insurance premium. This move will adversely affect the Insurance business, he anguished. Against these odds, the Public Sector LIC of India could remain as the Market Leader, even after 17 years of competition. The claim performance ratio of LIC is unmatched in the world. LIC continues to be a major contributor to the 5 year plans and contributed Rs 14 lakh crore to the 12th five year plan to the government, he informed.

The presentations of both the leaders were well received and appreciated by the audience.



# Seminar on 25 Years of Financial Reforms at Thiruvananthapuram

Seminar on 25 years of financial reforms Awas conducted on August 12 in AKG Hall in Thiruvananthapuram. It was organized by AKG Centre of Research studies along with Bank Employees Federation of India and All India Insurance Employees Association. Com Prakash Karat, Polit Bureau member of CPIM inaugurated the seminar with a brilliant analysis of the present economic and political situation of the country. He has called for an integrated fight against the Hindutva and the neoliberal forces by projecting the Kerala model of promoting the public sector as a case in point. This is because the Hindutva forces were being used to buttress the neoliberal policies by the ruling class that had evolved a consensus among them for pursuing with a renewed vigour. The public sector should set a model of performance against the critics of public sector clamoring for privatization. In Kerala the public sector has made commendable performance under LDF rule.

Com Shreekant Mishra, joint secretary AIIEA presented the paper on insurance reforms. While presenting the history of the reforms in insurance sector he questioned the ill-conceived motive of the successive Govts in pursuing privatization and opening up of insurance sector to foreign capital. The argument for raising FDI in insurance sector advanced by the Govt was the inadequacy of capital. This was the major reform in the insurance industry. Shreekant Misra questioned this argument by giving several examples. The standing committee on insurance reforms headed by Sri.Yaswant Sinha was against increasing FDI on insurance. When PSGI



companies and GIC have enough reserves at their disposal there was no need to privatise them on the pretext of inadequacy of capital. Not much FDI came to the country as was expected. Even after passage of the insurance amendment bill, the promoters of Indian companies sold their shares to the foreign players rather than the foreign companies bring in more capital. Com Shreekant lucidly explained that the reforms have not benefited either the national economy or the insuring people. He said a big struggle by all patriotic masses is necessary to reverse the economic direction of the government.

Com.Kodiyeri balakrishnan, CPM state secretary presided over the seminar. He categorically said that the real alternative to liberalization reforms is the activities of the present LDF Govt in Kerala. When the Modi Govt is selling the public sector on a large scale the LDF Govt. in Kerala is strengthening the public sector. Com. A .Vijayaraghavan, director of AKG study Centre welcomed the gathering. Prof.C.P.Chandrasekhar, wellknown economist in his principal address asked all progressive sections to protect the national wealth which is being appropriated by the corporates. The 25 years of financial reforms has weakened the financial sector. The financial sector including the banking is now controlled by the corporates. The public sector banking is being weakened. Democratic struggles should be waged for protecting the public sector. Prof.K.N Harilal, economist said that the interests of the international financial capital are advanced by the present Indian state. Com.C.J.Nandakumar, National president BEFI said that the reliability of the public sector banking is being destroyed by the rulers through their policies. Jose.K.Abraham, BEFI leader, who was the main coordinator of the seminar also spoke on the occasion.Com Anavoor Nagappan, District CPM secretary proposed the vote of thanks. The seminar was well attended by comrades from BEFI, AIIEA and other sections of the people. As a host division, Trivandrum AIIEA comrades provided the necessary help for the successful conduct of the seminar.

# Seminar on "GST – Implications" at Hyderabad

"People For India (PFI)" Forum, Hyderabad has organized a seminar on the topic "GST- It's Implications", on 21.07.2017, in the premises of Sundarayya Kala Nilayam, Baghlingampalli, Hyderabad. The seminar was presided over by Com. K Venu Gopal, Vice-President, AIIEA. Sri R Sashi Kumar, Charted Accountant; Com. M Saibabu, General Secretary, CITU, Telangana State and Prof. K Nageshwar, Former MLC were the Chief Speakers. Over 400 employees from Insurance, Banking, Central and State Govts., Postal, Telecom, Medical sectors, Retd. employees and people from different walks of life have attended the seminar and made it a huge success.

Inaugurating the Seminar, Com K Venu Gopal opined that the BJP Govt. is trying to make people believe that GST is the biggest financial reform since independence. While informing that the entire service sector is brought under 18 % Tax slab, he condemned the act of levying increased GST on Insurance premium. It is unethical to levy GST on the risk portion of Insurance Premium and it is a great burden on the policy holder, he said. This move will adversely affect the insurance business, he cautioned.

Sri R Sashi Kumar, in his address, informed that GST is actually a reform in the Indirect Taxes system and it is present in not single but in three forms viz., CGST, SGST, IGST and five rates viz., 0%, 5%, 12%, 18% & 28%. He said that the GSTN website will be in total control of the private corporate as they are the major shareholders. As more number of goods are brought in to the GST Orbit, the prices of essential commodities are bound to go up and there by surge in inflation, he cautioned.

Com. M Saibabu, while addressing the seminar, felt that GST cannot be implemented in India, due to the vast socio, economic, geographical differences prevailing in the country. He said, it is not correct to tax the few rich possessing 58% of the country's wealth and the innumerable others possessing only 7% of the wealth, alike, at a common rate. Prime Minister Narendra Modi, who opposed GST vehemently, when he was the Chief Minister of Gujarat, is now trying to project GST as his own brain child. This is a testimony to the double standards of the BJP Party, he ridiculed.

Prof. K Nageshwar, in his enlightening address, asked how Digital India, as being promoted vigorously by the Govt., is possible, when the GST on the Lap Tops and Computers, most used by students and youth, is increased. Raising the Slogan of "Skill India" on one hand, the Govt., levied tax on Pens, Pencils and exercise note books used by children, he commented. Those very people who gave the slogan of "Swatch Bharat", have levied GST on Sanitary Napkins and while calling for "Cashless Economy", levied GST on Debit/ Credit Cards, he pointed. GST was imposed

> even on the Wheel Chairs being used by the Physically Challenged and the Braille Paper used by the Blind, he anguished.

> All the speakers called for developing broader awareness among people, on all the anti-people policies being pursued by the government, by extensive usage of social media also.

The seminar concluded with Vote of thanks proposed by Com. K Venu Gopal.



### Seminar on Privatisation and Joblessness at Patna

A seminar on "Privatisation and Joblessness" was jointly organized by Insurance Employees' Association Patna Division, IEAPD-II & B.J.S.G.I.E.A in the auditorium of Bihar Industries Association, Patna on 22<sup>nd</sup> July 2017. While inaugurating the seminar, eminent economist Prof. Dr. N. K. Choudhary threw light on the evils of privatization, liberalization and globalization and its effect on employment. He said that privatisation not only kills jobs, it also brings about outsourcing, contractualisation and casualisation in a big way. He further said that with the advent of new economic and industrial policies in 1991 Joblessness and unemployment started growing fast.

Speaking on the occasion, Com. Shreekant Mishra, General Secretary Eastern Zone Insurance Employees' Association criticised NDA Government for jeopardizing the scope of employment. He said that public sector industries in Defence, Railways, Telecom, coal, Bank, Insurance are all under attack. The Government has decided to privatise public Sector General Insurance companies in which New India assurance is likely to be the first victim. He reiterated that if disinvestment and privatization become the state policy, LIC can never remain safe.

Nearly 250 participants attended the seminar, jointly presided by Com. V.K.Verma, Com. R.N.Choudhary and Com.S.N.Prasad. Com. Sanjay Jha, (Joint Secretary, AIIEA) Com. Om Prakash and Com. Vishal Saran (General Secretary of IEAPD & IEAPD-II) also spoke in the seminar.

### Medical Awareness Camp by Chennai-I

As part of its Diamond Jubilee celebrations, ICEU, Chennai Division-I arranged for a Medical Awareness Camp at Chennai on August 5, 2017. Two young and highly qualified doctors from the MIOT Hospital, Chennai, addressed the participants.

Dr.Benoy John, M.D., D.M (Cardiology) Director & Head, Dept. of Cardiology, MIOT International, Chennai, in his address, explained that interventional cardiology treatment is famous now-a-days for treatment that it is essential to have regular check-up of the functioning of the heart and in case of any abnormality, rush to a hospital without wasting time. After explaining the processes of Angioplasty, Blocks in the Coronary Arteries, Valve Therapy, Venogram, Heart Transplant, etc., he felt that with Health Insurance facilities available for the LIC employees, it would not be difficult for them to go in for specialized treatment for heart diseases.

Dr.Shankar Balakrishnan, M.D., D.M (Neurologist), MIOT Hospital, mainly dealt with the Parkinson's disease caused due to problems in the brain, and explained how the disease is diagnosed by scanning and treated by brain stimulation. He told the audience that

of heart ailments and went about explaining the types of blocks in the heart, various methods of surgery and treatment and stressed the need for people aged 45 and above to do regular exercises to avoid hypertension, which would lead to heart attacks. He also urged



there were five stages in the disease and in advanced cases Deep Brain Stimulation (DBS) is being done to cure the patient. He cited many examples to show how DBS improves the functioning of the limbs of patients, who got relieved from the disease. He also explained the various processes of insertion of Electrodes in the brain to make its functioning normal.

Both the doctors exhibited films which were helpful to the audience to understand the various procedures being adopted to cure the patients of their diseases. At the end, some comrades in the audience sought certain clarifications, which were explained by the doctors. To honour the doctors for their commitment and highly useful participation in the Camp, they were presented with Mementos. Com.K.David former manager of Insurance worker Journal presented memento to Dr.Binoy John and Com.K.Sridhar, Divisional Union Treasurer presented memento to Dr.Sankar Balakrishnan.

Com.S.Rameshkumar profusely thanked the doctors and also the audience, who participated in the camp.

# **CONFERENCE OF LICPA**, THANJAVUR

The 9th General Conference of LIC Pensioners'Association, Thanjavur Division was held on 12th July 2017 at com R G Ninaivarangam (Union office premises of ICEU/ Thanjavur Dn). After paying homage to comrades Dindigul R Narayanan, Com RG, departed leaders, pensioners of Thanjavur Division and others the session commenced.

Com K Lakshmanan, president,LIC PA, Thanjavur Dn presided. Around 120 pensioners, two central committee members of AIIPA from Tamilnadu and office bearers of LIC & GIC Pensioners Associations from Tamilndu Divisions attended the conference. Com R Balan, joint secretary welcomed the gathering.

COM K NATARAJAN, vice president, AIIPA, in his inaugural address, explained the rationale behind the decision of AIIPA to keep away from the legal battle indulged by some other organisations. He referred to the judgements of Jaipur, Rajastan and other High courts which vindicated AIIPA's stance that LIC has no powers to decide on the issues of Pensioners which can be decided only by the Central government through notification. Taking this fact into consideration and also certain observations made by the judges, while pronouncing the judgements, AIIPA reviewed the position and decided to enter into legal fray, he averred.. Senior counsel Sri Nag Mohan Dass, former Chief Justice of Karnataka High Court, who was engaged to argue our case, put forth his arguments most effectively in the Delhi High Court, Com Natarajan pointed out. He further observed that the judges were

very much impressed by the arguments of our counsel and made certain observations, which raised hope that the judgement would be favourable to us. But, unfortunately, the judgement was totally negative on the issue of UPDATION & provided only partial relief on the issue of 100% neutralisation, that too for a section of pensioners.

He further informed that AIIPA made a deep study of the judgement and after having consultations with our counsel, decided to file SPECIAL LEAVE PETITION in the Supreme Court challenging the same. He assured the pensioners that AIIPA would take care of the pensioners' demands and take suitable steps to achieve them. He made an appeal to liberally contribute to defray the legal expenses.

Com S R Krishnamurthy, Secretary, LIC PA, Thanjavur submitted the report. 8 comrades participated in the debate and enriched the report. After summing up by the Secretary, the report was adopted unanimously.

Com R Punniamurthy, Vice president, SZIEF and com S Selvaraj, General secretary, ICEU, Thanjavur Division greeted the conference and assured their support and cooperation to the pensioners.

Resolutions on Updation, 100% neutralisation of DA to pre 01.08.1997 retirees and other pending issues were adopted unanimously.

### **MEMORANDUM AGAINST GST**

As per call given by All India Insurance Employees Association (AIIEA), ICEU Machilipatnam Division met GST Council Member and Andhra Pradesh State Finance Minister Sri Yanamala Ramakrishnudu on August 4, 2017 at his Chamber in AP Assembly Secretariat and gave representation for withdrawal of GST on insurance premium. The delegation explained in detail to the Finance Minister that GST has become a burden on Policyholders. The Minister assured to take up the issue in GST COUNCIL



# **INSURANCE NEWS IN BRIEF**

- ► A report by CII-Price waterhouse Coopers,"Evolving Considerations for the Indian Insurance Industry", states that while global average investment in digital technologies is increasing Indian insurance industry is lagging far behind - both in its level of digitalization and its ability to realise financial returns on its digital investments. Mobile adoption and internet trends under Digital India\_banner are bringing in a new generation of customers who are conversant and comfortable with using technology for their financial decisions, it futher states. The Report also stresses on three key areas relevant to the insurance sector — simple products and low-cost distribution, digitisation and fraud management, and broadening the investment horizon
- Wannacry which has made many cry. The cyber attack threats have engulfed entire globe. India is the third worst hit country in the Wannacry attack. Hence there has been increase in demand for cyber crime insurance. But 55% companies in India do not have proper programme to assess the threat or a frame to determine the loss.
- Made for them, it seems so, if one goes by what has happened just last kharif and rabi seasons. They, the private insurance companies, have made a windfall of over Rs.16,700 crore in 2016-17. The tool is Pradhan Mantri Fasal Bima Yojana, which till recently was being allowed to be operated by the private companies only. These general insurance companies collected crop insurance premium of Rs.20,374 crore but paid out only Rs.3,655 crore to settle the claims. The claims filed were for Rs.5,650 crore. Government coolly says that there have been a few implementation problems even after Comptroller Auditor General (CAG) slapping it over the issue. In its performance audit report of Agriculture Crop Insurance Schemes, CAG has said, while huge funds were provided to private insurance companies, there was no provision to check whether the funds were properly utilised.
- It is being predicted that with GIC-Re going public there will be increase in the premium of health and motor insurance. GIC-Re has filed the draft red herring prospectus for public issue with SEBI. There are reports that LIC will be investing in GIC-Re.
- IRDA orders that all insurers having unclaimed amounts of policyholders for a period of more

than 10 years as on September 30, 2017 will have to transfer all such amount to Senior Citizens' Welfare Fund before March 1, 2018.

- ► An expert panel appointed by IRDA has recommended shifting to Risk-Based Capital (RBC) to fix the solvency ratios of the insurers. The panel says that the present system, which fixes the solvency ratios based on the reserves and the sum at risk for the life insurer, is not sufficiently transparent or risk-focused to adequately reflect the true financial conditions of the insurer. The RBC method, on the other hand, is risk-focused and follows the standards adopted in developed countries.
- Life insurance industry in India collected first year premium of Rs.53,659.66 crore during the period April-July 2017 registering an increase of 18.59% over the same period of last year. While LIC garnering Rs.39539.01 crores, an increase by 18.62%, has captured a market share of 73.68 %. With respect to number of policies during the said period LIC's market share works out to 74.86% procuring 5125173 policies.
- ► The first quarter of the present financial year has given LIC a whopping 145% increase in the profit on sale of equity investments. Last financial year during the period – April to June – LIC had made a profit of Rs.2489 crore, while this year for the same period LIC has garnered a profit of Rs.6100 on the sale of equity investments. During this period LIC has invested Rs.1600 crore in the equity market.
- ► Natural disasters have caused an estimated insured loss, world-wide, of US\$ 22 billion during the first half of 2017 (January to June 2017). 76 % of these losses are generated by the events in US. During the same period the global economic (uninsured) losses from natural catastrophes are estimated at US \$53 billion.
- ► In USA, recently some insurers and benefit managers are insisting the patients to forgo generics and buy brand-name drugs. Consumers are getting increasingly angry over what they pay for drugs. On one hand the insurers campaign favouring generics but in practice it is quite opposite. More often than not the pharmacists inform the patients that their insurance policy covers only brand-name drugs.

- The US House of Representatives have proposed a plan to cut more than \$ 5 trillion from social programmes over the next decade. The proposals include \$ 4 trillion cuts in Medicare and Medicaid, \$ 150 billion cut in food stamps, reduced support for student loans and grants and cut on social security disability coverage. Alongside the proposals to cut social programmes budget, there is a proposal to increase spending for US military spending to the tune of US \$ 929 billion to prepare for war and social unrest.
- The IMF has downgraded the forecast for growth of UK by 0.3% to 1.7% this year. The IMF forecast Chinese growth at 6.4% an increase of 0.2 points from the last quarter. The forecast for Japan was increased to 1.3% this year an increase of 0.1% and the euro union growth rate was revised upward by 0.2% to 1.9%. Of the major economies of G7, Canada's growth rate was 2.5% this year, up 0.6% from the last guarter. However, IMF has downgraded the growth of Canada from 2% to 1.9% next year. Maurice Obtsfled, the Chief Economist of IMF has said that in advanced economies, median incomes have stagnated and inequality has risen over several decades. Even as unemployment is falling, wage growth still remains weak which is reducing the living standards of vast majority, which has the potential risk of "exacerbating social tensions".
- The Indian Ministry of Defense (MoD) has requested Finance Ministry additional funds of Rs. 200 billion (\$ 3.1 billion) to speed up procurement of ammunitions, armaments and other war materials, due to the escalating tensions at Doklam between India and China. India's military budget has risen almost five fold from \$ 11.8 billion in 2001 to some \$ 56 billion now.
- According to a study by Global risk management firm Willis Towers Watson, in USA the employers reduced their expenditure on retirement benefits by a staggering 25% between 2001 and 2015. In addition to cutting retired and current workers' benefits, the Corporations have eliminated traditional "defined benefit" retirement benefits. replacing them with "defined contribution plans" under which the final payouts are largely determined by the vagaries of stock market. According to the study, the percentage of employers offering DB plans plummeted from 45% to just 7% between 2001 and 2015. According to the study, 44% of older workers (aged 55 plus) who are concerned about their future finances and 64% of those who are

struggling financially expect to work to age 70 or more.

- According to a study by Pew Research Centre, number of Americans aged 65 or more who are working jumped from 13% in 2000 to nearly 19% in 2016 and is expected to increase to 32% in the next five years. Over 25 million Americans 60 years or more are economically insecure, living at or below 250% of the Federal poverty level or \$ 29425 a year for an individual, according to the National Council on Aging. The study also notes that since the financial crash of 2008, the desire for retirement guarantees has been rising steadily, up 17 points since 2009.
- The unemployment rate of USA is 4.4%. According to the recent "Real Wage Index", the real wages in USA have fallen by 7.5% since 2006. In real terms, average wages in the US peaked more than 40 years ago. The share of US GDP to labour has fallen to the lowest level since the end of World War II. However, since post 2008 crisis low point of March 2009, the Dow has risen by 340% resulting in widening gap between rich and poor. According to US Labour department report, during the past four decades major work stoppages has declined by 90% and between 2007-2016, the average work stoppage by workers was just 14 per year.
- On 28<sup>th</sup> July 2017, Amazon's CEO Jeff Bezos became the world's richest person in the world for few hours after making a gain of \$ 1.4 billion when the shares of Amazon surged by 1.6% in the New York Stock Exchange. He holds 17% of the shares of Amazon. This is in sharp contrast to the low wages earned by Amazon's Global workforce.
- According to Federal Reserve, the Dow has risen by 11% this year and an investment of \$ 10000 made in 2007 would now be worth \$ 33600. However, only 15% of the US households hold stocks, majority being the financial elites.

# **WORKING CLASS STRUGGLES**

### Queensland: Brisbane bus drivers continue strike action

Brisbane City Council bus drivers held a four-hour strike on 2<sup>nd</sup> August in protest against a proposed enterprise agreement offer by the council. The strike followed two two-hour stoppages and a four-hour stoppage over the past two weeks. Rail, Tram and Bus Union (RTBU) members want the agreement to improve wages and safety and allow workers to have a say in shift arrangements.

Nationwide strike by educators set in Chile Following an August 5 national assembly, Chile's College of Professors union announced a strike for August 17. The nationwide stoppage will protest the recent passage of a law called New Public Education (NEP), which union president Mario Aguilar said "does not resolve the great problems in Chilean education" and "maintains the logic of the market," further threatening public education. The walkout will also protest delays in payments of wages and benefits owed by some municipalities. Hundreds of teachers from San Fernando, began a march August 4 to Santiago to demand an audience with president Michelle Bachelet and the education minister.

#### 72-hour strike by Uruguayan anesthesiologists over pay dispute

The Surgical Anesthesiologists Syndicate (SAQ) in Uruguay called a three-day strike August 2-4 to demand that the State Health Services Administration (ASSE) comply with agreements reached in 2007 and ratified in 2008 and 2010. According to the SAQ, the ASSE had agreed to equalize pay for the 2,000 anesthesiologists, but failed to carry out the promise.

#### Colombian hospital workers strike for overdue pay

Workers for the University Hospital of Santander (HUS) in Colombia walked off the job August 5 following failed talks with Darsalud, their contract employer, over unpaid wages for the last three months. Striking workers protested in front of the hospital, intermittently blocking the entrance and declaring their resolve to continue their industrial action until they have been paid.

### Nicaraguan public transit workers strike over infrastructure improvement demands

Public transport drivers in the city of Boaco, Nicaragua stopped work on August 3 to press their demands for infrastructure improvements. The drivers struck after having submitted several fruitless petitions to the city council of Boaco, the capital city of the department of the same name Hundreds of buses were grounded by the action. Toronto legal aid workers set to strike

Workers at West Toronto Community Legal Services (WTCLS) have voted to go on strike after the employer cut their monetary offer in half in retaliation for an appeal by their union to the Ontario Labour Relations Board (OLRB). The workers at WTCLS, which is funded by Legal Aid Ontario, provide legal and housing support to low-income and disabled people in the area. After rejecting the employer's latest offer workers delivered a unanimous strike vote to their bargaining agent, the Ontario Public Service Employees Union (OPSEU).

### Nuclear workers in northwest England to be balloted for strike

Around 5,000 staff employed by Sellafield Ltd, which is part of the Nuclear Decommissioning Authority, are to ballot for possible strike action. They are members of the Unite and GMB unions and are protesting the imposition of a 1.5 percent pay increase, which is below the inflation rate and has been preceded by years of inadequate increases amounting to cuts in real pay terms.

Protest and strike threat by Croatian ship workers On August 7, workers employed by the Croatia state owned shipping company, Jadrolinija, held a protest in Split and threatened strike action. They are members of the Independent Union of Seafarers of Croatian Passenger Ships. They have several grievances relating to their pay and conditions. They have not had a pay increase for 10 years and recently had their pay cut. Some workers have no security, being on fixed term contracts. Some on-board staff are expected to work 19 hours in a row in contravention of the legal limit of a 14-hour day.

#### Pilots and engineers strike over redundancy payments at Nigerian airline

Airline pilots and engineers have declared a national strike over the sacking, without termination payments, of 600 of their colleagues at Aero Contractors of Nigeria Company.

The airline company is currently being bailed out by the state-financed Asset Management Corporation of Nigeria (AMCON) with the resulting loss of jobs.

#### Ugandan rail workers strike over unpaid wages and security funds

Hundreds of rail workers went out on strike July 26 in Uganda demanding the payment of June and July's wages.

Lapsed policies : "The premium from lapsed policies cannot be transferred to shareholders fund. It remains in the life fund and gets distributed to those who are regularly paying premium," IRDAI member (Life) Nilesh Sathe said.

Unclaimed amounts: IRDAI has asked insurance companies to move the unclaimed monies, which are unclaimed for 10 years from the date it was payable to the policyholder or the beneficiary, to the Senior Citizens Welfare Fund, which has been created by the government. Unclaimed amount is money that is due to policyholders or beneficiaries in the form of death claim, maturity claim, survival benefits, premiums refunds or indemnity claims—including accrued interest—but has not been claimed for more than 6 months since the settlement date. However, policyholders and beneficiaries are eligible to claim it up to 25 years from the date of transfer of the same to the Senior Citizen's Welfare Fund.

Digitisation failure: Less than 2% of the insurance policies have been digitised even after 4 years of it's introduction. India is the only country which is trying to digitise insurance policies. LIC is not participating in this system to avoid additional costs. Instead, LIC has started it's own e-services which can be used to avail of a list of services including viewing the policies in an electronic format. According to Private Insurance Cos., policyholders are seeking physical document even after digitising and hence they are incurring more expenses. But, IRDAI is indicating that it'll be made compulsory in next 2 years.

LIC 51% growth : In July 2017, LIC reported an increase of 51.4% in premium during the month at Rs.16,254.91 crore as against Rs.10,737.92 crore in July 2016. For 23 private sector players, the total business premium last month increased 34% to Rs.4,172.76 crore from Rs.3,116.52 crore.

LIC need not : LIC does not have to reduce its stakes to 15% or less in companies where it has strategic investments, like Corporation Bank and LIC Housing Finance. IRDAI has asked LIC to reduce its stakes in L&T and ITC to 15% by December 2018. Moreover, it would extend the time by a year for LIC to reduce its stakes in these two companies if LIC needed more time.

**Rs.4 Lakh Cr investment**: LIC is looking to invest around Rs.4 lakh crore in fiscal year 2018. This will be its highest ever investment in absolute terms.

**145% jump in profit:** LIC has registered a whopping 145% jump in profit, from Rs.2,489 Crs to Rs.6,100 Crs, from sale of equities in the April-June quarter of the current financial year.

### **For our Field Force**

**Claims without Death Certificate**: The Gujarat and Assam floods are being ranked among the biggest natural disasters. LIC is obtaining a list of deceased from the state government and reaching out to the victims' relatives to settle death claims. LIC has waived the death certificate requirement for such settlements and would pay out claims on the basis of documents issued by state authorities.

**Policyholder money loot**: According to IRDAI, Rs.78 crore was siphoned off from the books of the Sahara India Life Insurance Co. in 2014-15 and transferred to the parent company Sahara India on the pretext of opening 650 new offices, in violation of the Insurance Act.

**Expense ceiling:** The overall expense ratio for the life insurance industry (excluding Aviva Life, Sahara Life and Bharti AXA Life) was 15.5% in 2015-16. **LIC has the lowest expense ratio of 8.5%.** IRDAI chairman T.S. Vijayan hinted that a cap on insurers' expense ratio will be made mandatory.

Growth from Demonetisation: Premium collected by life insurance companies more than doubled in November when demonetisation was announced. A study by the Reserve Bank of India, named Mint Street Memo, noted that most of these were single-premium policies where the amount is paid in lump sum rather than periodically. (LIC wasn't able to collect old notes. It seems Banks have diverted the deposited amounts to the insurance companies promoted by them.)

Highest GI Growth : The general insurance industry reported its highest-ever year-on-year growth of 32% in premium collection in FY17 because of crop insurance. And in July, for the first time, private sector non-life insurance companies moved ahead of the four state-owned companies in premium collection. In FY17, private sector general insurers reported a growth of 35%, driven by crop insurance as they had 73% share in crop insurance business.

**Insurance gets attraction :** With gold losing sheen and real estate prices cooling off, it is expected that Indian households will prefer financial products, including insurance, for savings.

**Aadhar not mandatory :** IRDAI has clarified that Aadhar is not a mandatory requirement for Know Your Customer (KYC) in the insurance sector.



Professor PM Bhargava the founder-director of Hyderabadbased Centre for Cellular and Molecular Biology (CCMB) died on August 1. He was 89.
