## **TESTING TIMES FOR INDIAN DEMOCRACY**

India is in the process of voting for a new **L** government. The voting which began on  $11^{\text{th}}$ April will end on 19th May, 2019 in a seven phase election. This is a crucial election in the background of deepening crisis of global capitalism and the slowing down of the Indian economy. The people expected the political parties to present their vision as to how they will tackle the fundamental issues like unemployment, agriculture distress and inflation to help them make an informed decision. But it is disappointing that the ruling party led by the Prime Minister is making all efforts to avoid dealing with all these issues impacting the daily life of the people. The Prime Minister feels he is not answerable for the promises made during the last elections. Therefore, the entire campaign is focused on polarisation of communities and built on pseudo-nationalism. Never in the past was the discourse as low as it is seen during these elections.

Politics is no longer about service to the people and a vision for constructing the

society. Politics today has become the most profitable industry. Therefore, elections have to be won at all cost; it does not matter even if the actions resorted to harm the very unity of the nation. We see certain clear trends in this election that are worrying and pose long term threat to democracy. Prominent among these trends is the blatant misuse of official machinery to intimidate the rivals. It is true that the ruling parties have always misused the official machinery but the scale of its misuse today is unprecedented. The income tax raids, the actions of the Enforcement Directorate against the leaders of the opposition parties clearly are acts of intimidation that even the timid Election Commission had to caution these agencies to be non-partisan in their approach. Not just the opposition parties even the voters are being threatened and intimidated. A Gujarat lawmaker tells the voters that Modi has installed cameras in the voting booths and BJP would come to know who did not vote for the party. Menaka Gandhi

warns the minorities that she would not attend to their grievances if they do not vote for her. This raises the most fundamental question – who should the State work for. Will the State work for all its citizens or only supporters of the winning party? If the lawmakers say they will work only for those who voted for them, it would be a sure death for participative democracy.

The second trend is the unprecedented hate campaign in this election. Elections are to decide the path of economic, social and political development of the country. By no stretch of imagination it is a fight between Ali and Bhajrangbali. Today both Ali and Bhajrangbali are suffering due to lack of jobs, increasing price rise and unprecedented rural distress. The politics of communal hate is to divert the attention from the real issues impacting the lives of people belonging to all communities. Let it be clear that the appeal for votes on communal lines by the opposition too cannot be condoned. This campaign has also seen sexy comments by a number of leaders and candidates betraying their attitude towards women.

Perhaps Prime Minister Modi has forgotten his slogan of sab ka saath sab ka vikas. His actions suggest that he is content to be the Prime Minister of his party and its supporters rather than being the Prime Minister of the country. His open communal remarks and attempts to other the minorities are clearly seen in his election speeches. His comments that Rahul Gandhi is scared of the Hindu dominated constituencies and therefore has chosen to contest from minority dominated Waynad constituency are not only distasteful but also raises questions on his understanding about minorities as citizens of this country. His party President wondered if Waynad is in Pakistan. This is atrocious and unforgivable. Amit Shah has been extensively speaking on National Register for Citizens and without any ambiguity has been saying that citizenship will be decided on the basis of religion. Certain decency is also expected from Rahul Gandhi when he speaks about the Prime Minister.

Thirdly, this election campaign has seen dangerous politicisation of our armed forces. The Election Commission directive not to politicise the defence forces is flouted repeatedly by the Prime Minister himself. The Prime Minister has been asking for votes in the name of CRPF Jawans martyred in Pulwama while refusing to accept the responsibility for the security lapses that led to their unfortunate deaths. Encouraged by the attitude of the Prime Minister, Yogi Adityanath has called our armed forces as 'Modiji ki sena'. Despite these blatant violations of model code of conduct, the Election Commission is timid to take any action against the powerful. The politicisation of armed forces has come under severe criticism from the veteran soldiers. Over 150 high ranking officers including the former chiefs of the three wings of armed forces have written to the President to intervene and immediately stop using the armed forces for electoral benefits. It is not known how the President will act on this complaint. The President is also sitting on the suggestion of action by the Election Commission against a Governor who despite being a constitutional authority had been campaigning for BJP.

This election has also seen unprecedented levels of money power. The government has legitimised non-transparency through the Electoral Bonds. The argument of the Attorney General that voters do not have any right to know how and who funds the political parties is arrogance of the highest order. It is revealed that 95% of the donations received through Electoral Bonds have gone to BJP. It is common knowledge that corporate funding of political parties is a quid pro quo. This impacts the interests of the common people. The current parliament has the highest number of crorepatis and the overwhelming majority of the contestants in the current elections are also crorepatis. The Indian Parliament and the State have become hostage to the moneyed and the rich. Therefore to save democracy, the electoral reforms including proportionate representation and State funding have become an immediate necessity.

The working class has borne the brunt of the economic policies in the last five years. But these attacks did not go uncontested. The country witnessed massive strike actions by the workers, farmers, students, youth and women. These sections of the population must ensure that their issues occupy a prime position in the election campaign. The Left which has led and aided these struggles has to be strengthened. Left is the voice of the poor and the dispossessed and this voice must resonate in the Parliament. The country



has to be saved from communal forces and a neoliberal regime; forces that defend a plural India and work for economic and gender justice must be supported. Long years ago, Dr B.R.Ambedkar had warned **'that in politics, Bhakti or hero-worship is a sure road to degradation and to eventual dictatorship'.** This warning of Dr Ambedkar is more relevant in today's India than ever before. These are truly testing times for Indian democracy. It is the responsibility of the working class to prevent Indian democracy from falling sick.

## भारतीय जनतंत्र के लिए परीक्षा की घड़ी

भारत एक नई सरकार चुनने के लिए मतदान की प्रक्रिया में है। 11 अप्रैल को शुरू हुआ मतदान 19 मई, 2019 को सात चरणों में सम्पन्न होगा। यह चुनाव वैश्विक पूंजीवाद के गहराते संकट और भारतीय अर्थव्यवस्था के धौमे पड़ने की पृष्ठभूमि में अत्यन्त महत्वपूर्ण है। लोगों ने राजनीतिक दलों से अपेक्षा की थी कि वे अपना दष्टिकोण पेश करेंगे कि कैसे वे बेरोजगारी, कषि संकट और मुद्रास्फीति जैसे बुनियादी मुद्दों से निपटेंगे ताकि उन्हें एक जानकारी पर आधारित निर्णय लेने में मदद मिल सके। लेकिन यह निराशाजनक है कि प्रधानमंत्री के नेतृत्व वाली सत्तारूढ़ पार्टी लोगों के दैनिक जीवन को प्रभावित करने वाले इन सभी मुद्दों से बचने के लिए समस्त प्रकार के प्रयास कर रही है। प्रधानमंत्री को लगता है कि वह पिछले चुनावों के दौरान किए गए वादों के लिए जवाबदेह नहीं हैं। इसलिए पूरा अभियान समुदायों के ध्रवीकरण पर केंद्रित है और छंदा राष्ट्रवाद पर निर्मित है। अतीत में कभी भी विमर्श इतना संकीर्ण नहीं था जितना इन चनावों के दौरान देखा जा रहा है।

राजनीति अब लोगों की सेवा करने और समाज के निर्माण के लिए एक दृष्टिकोण प्रस्तुत करने वाली नहीं रही है। राजनीति आज सबसे अधिक लाभदायक उद्योग बन गया है। इसलिए चुनाव हर कीमत पर जीतना होता है, इससे कोई फर्क नहीं पड़ता कि इससे राष्ट्र की एकता को ही नुकसान पहुंच रहा है। इस चुनाव में हमें कुछ स्पष्ट रूझान दिखते हैं जो चिंताजनक हैं और लोकतंत्र के लिए दीर्घकालिक खतरा पैदा करते हैं। इन प्रवृत्तियों के बीच एक प्रमुख प्रवृत्ति है– प्रतिद्वंदियों को डराने के लिए आधिकारिक मशीनरी का दुरूपयोग। यह सच है कि सत्तारूढ़ दलों ने हमेशा आधिकारिक मशीनरी का दुरूपयोग किया है लेकिन आज इसका दुरूपयोग अभूतपूर्व पैमाने पर हो रहा है। आयकर छापे तथा विपक्षी दलों के नेताओं के खिलाफ प्रवर्तन

निदेशालय की कार्यवाही स्पष्ट रूप से डराने-धमकाने के लिए है, यहां तक कि डरपोक चुनाव आयोग को भी इन एजेंसियों को अपनी कार्य-पद्धति में पक्षपातपूर्ण न होने के लिए आगाह करना पड़ा है। सिर्फ विपक्षी दलों को ही नहीं मतदाताओं को भी डराया और धमकाया जा रहा है। गुजरात के एक विधायक ने मतदाताओं को बताया कि मोदी ने मतदान केदों में कैमरे लगाए हैं और भाजपा को सब पता चल जायेगा कि किसने पार्टी को वोट नहीं दिया है। मेनका गांधी ने अल्पसंख्यकों को चेतावनी दी है कि अगर वे उन्हें वोट नहीं देते है तो वह उनकी किसी शिकायत की कोई सनवाई नहीं करेंगी। इन बातों से बुनियादी सवाल यह उठता है कि राज्य को किसके लिए काम करना चाहिए। क्या राज्य अपने सभी नागरिकों के लिए काम करेगा या केवल जीतने वाले दल के समर्थकों के लिए? यदि विधान बनाने वाले कहते हैं कि वे केवल उन लोगों के लिए काम करेंगे जिन्होंने उनके लिए मतदान किया था तो यह सहभागी लोकतंत्र के लिए निश्चित रूप से मौत होगी।

दूसरी प्रवृत्ति इस चुनाव में अभूतपूर्व घृणा अभियान है। चुनाव देश के आर्थिक, सामाजिक और राजनीतिक विकास का रास्ता तय करता है। कल्पना की किसी भी सीमा तक यह अली और बजरंगबली के बीच की लड़ाई नहीं है। आज अली और बजरंगबली दोनों ही नौकरियों की कमी, मूल्य वृद्धि और अभूतपूर्व ग्रामीण संकट के कारण पीड़ित हैं। सांप्रदायिक घृणा की राजनीति वास्तविक मुद्दों से ध्यान हटाने के लिए है जो सभी समुदायों के लोगों के जीवन को प्रभावित करती है। हमें यह स्पष्ट पता होना चाहिये कि विपक्ष द्वारा सांप्रदायिक आधार पर वोट मांगने की अपील को भी क्षमा नहीं किया जा सकता है। इस अभियान ने कई नेताओं और उम्मीदवारों द्वारा महिलाओं के प्रति उनके कपटपूर्ण सेक्सी टिप्पणियों के रवैये को भी देखा है।

शायद प्रधानमंत्री मोदी ने सब का साथ सबका विकास के नारे को भुला दिया है। उनके कार्यों से पता चलता है कि वह देश के प्रधानमंत्री होने के बजाय अपनी पार्टी और उसके समर्थकों के प्रधानमंत्री होने में ही संतुष्ट हैं। उनकी खुली सांप्रदायिक टिप्पणी और अल्पसंख्यकों को पराया बनाने के प्रयासों को उनके चुनावी भाषणों में स्पष्ट रूप से देखा जा सकता है। उनके बोल कि राहल गांधी हिंदु बहुल निर्वाचन क्षेत्रों से उरते हैं और इसलिए उन्होंने अल्पसंख्यक बहुल वायनाड निर्वाचन क्षेत्र को चुनाव लड़ने के लिए चुना है, न केवल वैमनस्य दर्शाते हैं, बल्कि इस देश के नागरिकों के रूप में अल्पसंख्यकों के बारे में उनकी समझ पर भी सवाल उठाते हैं। उनकी पार्टी के अध्यक्ष ने तो आश्चर्य प्रकट किया था कि क्या वायनाड पाकिस्तान में है। यह क्रूर और अक्षम्य है। अमित शाह बड़े पैमाने पर नागरिकों के लिए राष्टीय रजिस्टर पर बोल रहे हैं और बिना किसी अस्पष्टता के कह रहे हैं कि नागरिकता का फैसला धर्म के आधार पर किया जायेगा। जब राहुल गांधी प्रधानमंत्री के बारे में बोलते हैं तो उनसे भी कुछ शालीनता की उम्मीद की जाती है।

तीसरे, इस चुनाव अभियान ने हमारे सशस्त्र बलों के खतरनाक राजनीतिकरण को देखा है। रक्षा बलों का राजनीतिकरण न करने के चुनाव आयोग के निर्देशों का उल्लघंन खद प्रधानमंत्री द्वारा बार-बार किया जाता है। प्रधानमंत्री पुलवामा में शहीद सीआरपीएफ जवानों के नाम पर वोट मांग रहे हैं, जबकि सुरक्षा में चूक के लिए जिम्मेदारी लेने से इंकार कर देते हैं, जिसके कारण इतनी दुर्भाग्यपूर्ण मौते हुईं। प्रधानमंत्री के रवैये से उत्साहित होकर योगी आदित्यनाथ ने हमारे सशस्त्र बलों को ?मोदीजी की सेना? कह दिया है। आदर्श आचार संहिता के इन जबरदस्त उल्लंघनों के बावजूद, चुनाव आयोग शक्तिशाली लोगों के खिलाफ कोई कार्यवाही करने से डर रहा है। सशस्त्र बलों का यह राजनीतिकरण अनुभवी सैनिकों की कड़ी आलोचना के वावजूद हो रहा है। सशस्त्र बलों की तीनों शाखाओं के पूर्व प्रमुखों सहित 150 से अधिक उच्च रैंकिंग अधिकारियों ने राष्ट्रपति से हस्तक्षेप करने और चुनावी लाभ के लिए सशस्त्र बलों का तुरन्त दुरूपयोग रोकने के लिए लिखा है। हमें नहीं पता कि राष्ट्रपति इस शिकायत पर क्या कार्यवाही करेंगे। राष्ट्रपति, चुनाव आयोग द्वारा एक राज्यपाल के खिलाफ कार्यवाही के सुझाव पर भी चुप बैठे हैं, जो एक संवैधानिक प्राधिकारी होने के बावजुद बीजेपी के लिए प्रचार कर रहे थे।

इस चुनाव में पैसे की शक्ति का अभूतपूर्व स्तर पर प्रदर्शन हुआ है। सरकार ने गैर–पारदर्शिता को चुनावी बांड के माध्यम से वैध किया है। अटॉर्नी जनरल का यह

The Joint meeting on wage revision was held at Mumbai on April 04, 2019. The meeting, termed as exploratory was attended by the Chairman, GIPSA, CMDs and GMs (P) of all the PSGICs including GIC:Re, Chief executive, Sr. Vice President and Vice President of GIPSA and two representatives from each check off qualified Union/ Association. AIIEA was represented by Coms. Amanulla Khan, President and Sanjay Jha, Secretary, Standing Committee (GI).

The meeting began with welcome address by Sri A.V. Girija kumar, Chairman, GIPSA and CMD, OIC. He congratulated the Associations on the achievement of the final option of Pension under 1995 Scheme and informed that the notification on the same is likely in next ten days. He also informed that the factors for cost sharing suggested after discussion with LIC is 3.7 times the current basic pay for existing employees. The retired employees have to refund 1.3 times of the amount they received as employer's contribution of PF and interest.

He expressed his satisfaction on a decent performance of the PSGICs on various business parameters during the last five years. He also dealt in detail on the challenges currently being faced by the Public Sector Insurance Industry. Sri Ravi Rai, Chief Executive, GIPSA, through Power Point Presentation provided detailed insights into the performance of Public Sector General Insurance on various criteria viz. Growth Rate, Market Shares, ICR, Combined ratios, Management expenses etc. He also delved into the shortcomings in their functioning and the threats being presented by the Private insurers. However, no offer for upward revision of wages was made.

Responding on behalf of AIIEA, Com Amanulla Khan, President thanked the Management for successful conclusion of the issue of Pension option and also stated लोकतंत्र को बचाने के लिए आनुपातिक प्रतिनिधित्व और राज्य द्वारा चुनाव के लिए वित्त पोषण सहित चुनाव सुधार तत्काल आवश्यक बन गए हैं।

that imposition of cost sharing on employees has taken away the grace of conceding this long standing demand. He stressed that the Companies were capable of bearing the entire cost of the final option. He further stated that due to its commitment to the institution, AIIEA shares the concerns of the Management on the challenges being confronted by the PSGICs in the competitive market; but these issues need to be discussed on a regular basis and should not be linked to wage negotiations. He suggested the Management to hold a separate workshop with Associations on the challenges being faced by the PS General Insurance Companies.

He asserted that the performance of the GI industry is interwoven with the overall economy. The Indian economy has registered a drastic reduction in private investments, capital formation and savings rate in the recent few years. In this scenario, the performance and growth shown by the PSGICs are commendable. He emphasised that looking at the various business criteria in relation to the Premium procured, it is obvious that the PSGICs, over the few years have shown a steady improvement in productivity, ICR, Combined ratios, profitability, underwriting experiences etc. The workforce of the Companies including the Managements deserves appreciation for the same. Hence, it is quite legitimate on the part of the employees to aspire for a satisfactory revision of their wages and the GIPSA should come forward with a meaningful offer early. This is necessary to have proper negotiations and taking it forward towards a culmination early so as to channelize the energies of everybody connected with the industry to meet

the challenges of competitive atmosphere, regulatory changes and government policies.

Com. Amanulla Khan said that the Charter submitted by AIIEA is a reflection of hopes and aspirations of the employees. He made it clear that wage revision has to be industrywise; the external developments should not be allowed to influence the wage talks; the entire DA as on 1.8.2017 be merged with the Basic and loading on this should not be less than what was decided in the last wage revision. He further said that retiral benefits should be given necessary attention. The demand for periodical updation of Pension and increase in the family pension has to be looked into seriously.

The CMDs of the Companies, while giving their observations appreciated the suggestion for a separate workshop on challenges confronting the industry. The Chairman, GIPSA in his concluding remarks said that though GIPSA could not make any offer for wage increase, it is making all efforts to settle the issue as early as possible. He requested the Associations to cooperate with GIPSA and bear with some unavoidable delay. He however assured that GIPSA would make all efforts to meet the hopes and aspirations of the employees.

Comrades, the talks on wage revision have begun. It would be a long and hard battle to secure what legitimately belongs to us. The AIIEA is determined to secure a good wage revision. We request the employees to remain vigilant and in preparedness for any eventuality in our onward march towards securing a good wage revision.



May Day is the day of international solidarity of the working class. On this day it is our bounden duty to remember the sacrifices made by working class all over the world. It is a day to remind ourselves that it is due to the selfless sacrifices of countless workers that we are enjoying our present benefits and privileges. We must not forget that whatever rights and benefits we are enjoying today have not come as a charity from our rulers, these are the fruits of hard struggle of our ancestors. We must understand that had there been no sacrifices in the past, the present would not have been what it is today. We cannot and must not forget the glorious traditions of the May Day.

"Eight hours for work, eight hours for sleep and eight hours for what we will do" - these words still reverberate in our mind. In the late 19<sup>th</sup> century, the working class was in constant struggle to gain the eight-hour working day. Working conditions were very severe then; it was pretty much usual for the workers to slog 10-15 hours a day in absolutely unsafe conditions. Death and injury at the workplaces were a recurrent feature. Exploitation of workers was commonplace. Workers were afraid of protesting. Fear of losing their jobs and earning the wrath of their employers constantly haunted them. Often, protests of workers were being ruthlessly attacked by private armies of the employers like the Pinkerton Gang. During this time the idea of Socialism had started taking roots. Many of the workers were drawn towards the socialist ideology of working-class control over the production and distribution of wealth. The demand of Eight Hour working day started gathering momentum. The Federation of Organised Trades and Labour Unions (which

#### later became the American Federation of Labour) proclaimed in its national convention in Chicago in 1884 that "eight hours shall constitute a legal day's labour from and after May 1, 1886".

On May 1, 1886 more than 300,000 workers in 13,000 businesses across the United States walked off their jobs in the first ever May Day celebration. Chicago was the epicentre of the Eight-hour agitation where 40,000 workers went out on strike and many more joined them subsequently. On May 3, 1886 violence broke out at the McCormick Reaper Works between police and the workers. In the police brutality that ensued, at least two strikers were killed and many were injured. This incident enraged the workers and galvanised them into action. A public meeting was called the following day at Hay Market Square to discuss the police brutality. As the police began to disperse the crowd, a bomb was thrown into the police ranks. What followed thereafter was virtual mayhem. Exact number

of those killed or wounded have not been determined till date. Till date, interestingly, nobody knows who threw the bomb. But what is certain is that no worker was involved. An agent provocateur working for the police is believed to have thrown the bomb. But eight leaders of the demonstration - Albert Parsons, August Spies, Samuel Fielden, Oscar Neebe, Michael Schwabe, George Engel, Adolf Fischer and Louis Lingg - were arrested and convicted of murder. In a classic case of mockery of justice, on November 11, 1887 Parsons, Spies, Engel and Fischer were hung to death. Louis Lingg, as a mark of protest against the crass injustice, took his own life with an explosive device in his mouth.

In December 1888 from the Conference of the American Federation of Labour held at St. Louis, it was decided that from May 1, 1890 May Day would be observed by the working class throughout the U.S.A. The first Congress of the Second International in Paris in 1889 called upon the working class throughout the world to observe May 1 as the May Day. The Zurich Congress of the Second International in 1893 declared that May Day should be observed not only to voice the demand for an eight-hour working day, but it should be turned into a day for mobilizing the working class to destroy class divisions by bringing about social change. Since that time May Day is being observed every year by the working class with the avowed objective of destroying capitalism and ushering in a social change in favour of the toiling people.

The famous Italian philosopher Antonio Gramsci had said, "The crisis consists precisely in the fact that the old is dying and the new cannot be born. In this interregnum, a great variety of moribund symptoms appear" (Prison Notebooks, 1930). As we set out to celebrate May Day 2019, we find that there indeed are a great variety of 'moribund symptoms.



astounding. While the rich are getting richer the poor are getting poorer. The house always wins' - say those who run the casinos because in a casino all gambling is designed so that the house (the casino owners) will always make a profit. This seems to be happening with the rich and super rich today. The rich have withdrawn their wealth from investment or taxation. They have ploughed it into such financial instruments that do little good to the economy or the workers. The rich are in fact hoarding the wealth produced by the workers. The workers are fully aware that they are being exploited. They are angry over their exploitation. And this anger is festering gradually. This festering anger could turn into aggression. It could threaten the lives of the rich. It could set their empires afire. But that is not happening! The reasons are obvious.

Capitalism is in disarray. Inequality rates are

Like the fascists of the last century -Adolph Hitler of Germany, Benito Mussolini of Italy, Francisco Franco of Spain, Hideki Tojo of Japan and Antonio de Oliveira Salazar of Portugal - we have a new breed of rulers to silence the workers. These rulers do not wear the uniform of the military. They also do not take the help of the military to silence the workers. They simply tell the workers and the unemployed not to be angry with the rich. They say that the rich have earned their wealth by ingenuity and hard work. They say that it is not the business of the workers and the unemployed to worry about the rich. They try to silence the workers by saying that it is neither the rich nor the state apparatus that are to blame for their wretchedness and humiliation. The new ruling classes advise the workers not to target the rich. They advise the workers to turn their guns against the socially marginal. The ire of the workers is made to be directed not at the rich and powerful exploiting classes but towards the vulnerable and weak. Mostly it is the migrant. It is said that it is the migrant who is taking away the jobs from the workers and the unemployed workers. The new rulers would have us believe that the migrant must suffer for the plight of workers and the unemployed. We are made to agree that the migrant has to pay a price for the failure of capitalism! If it is not the migrant, then it is some other social group - the minorities or the drug dealer or the terrorists. And it is not only the police that has to take charge, militia groups also emerge to intimidate society into silence. One must remember therefore that the

attacks on migrant Bihari workers in Gujarat is closely linked to the lynching's of Dalits and Muslims in many parts of India and to the murder of supposed drug dealers in the Philippines and to the shooting of black men and women by police officers in the United States.

The tragedy today is that the villain of the piece i.e. the capitalist class goes scot free. The victim – the migrant labourer, the minority, the Dalit, the untouchable and other marginalised groups - are branded as villains. Not only as villains but as sociopaths - meriting nothing but contempt and hatred. This contempt and hatred have given rise to an acerbic form of nationalism - a nationalism not rooted in love of fellow human beings but in hatred of the so-called outsiders. The basis of the new nationalism is not 'love' but 'hatred'. The new nationalism is not inclusive, it is exclusive in nature. This is not the nationalism invoked by Gandhi during India's struggle for freedom, this is the nationalism invoked by Hitler in Germany. Patriotism is reduced to the hatred of the migrant worker, the minorities, the socially marginalised groups. So much so that the attention of the workers is turned away from their real problems: from the problem of low wages, from the problem of unacceptably long and inhuman working conditions, from the problems of unemployment and underemployment, from the problems of starvation, from the problems of education and health care etc. Workers' attention is diverted away from real to bogus issues. Eminent historian Vijay Prashad notes, "It is one thing to be patriotic about flags and anthems. But it is another thing to be patriotic against starvation and hopelessness."

This May Day beckons all of us to draw inspiration from the sacrifices of the martyrs and sensitise the working class to their real issues. We must sensitise the working class to the problems of joblessness, of unemployment, of hunger and malnutrition and above all of their exploitation. We must sensitise them to develop a class struggle by enhancing their class consciousness against the exploitative and inhuman nature of the capitalist system. The solidarity between workers and peasants that we have witnessed in India in recent times, the historic struggle of the peasantry and the huge success of the 8-9 January two-day nationwide strike are pointers to the possibility of a 'new awakening' on the eve of this May Day.

The AIIEA finally achieved the Final Option L to join the Pension Scheme 1995 for the employees of LIC and GIPSA companies who could not join earlier after a relentless struggle of more than a decade. It was an arduous journey right from August 2002 to February, 2019. The last decade witnessed intense struggles and campaign to achieve this demand. In the face of sustained agitation and continuous follow up by LIC and GIPSA, the government finally gave approval for a final option on 1<sup>st</sup> March 2019 through a tweet by Finance Minister and a press statement by Department of Financial Services. But this demand was conceded not with grace but by imposing cost on the employees despite provisions in the 1995 Pension Notification that the entire cost has to be borne by the institutions. Nevertheless in the current political and economic environment, it is a great victory achieved by struggles of employees in which AIIEA played a leading role. With the finality reached on this issue, it is pertinent to trace the history of pension and the struggles led by AIIEA to reach a successful closure on an important demand.

#### Pension is a deferred right for old age —Insurance employees must have it

The need for Pension became very acute in the 1980's with the country abandoning its welfare state character and fully embracing neo-liberalism. The declining interest rates to help the borrowings by the big corporate houses, improvement in the life span and breakdown of the family systems created necessity for a secure post retirement benefit by way of Pension. Therefore, the AIIEA during wage negotiations in December, 1988 raised the demand for introduction of Pension Scheme. The AIIEA substantiated this demand with sound reasoning but LIC turned down these arguments on the plea that government is opposed to introduction of any new retirement benefit. Similar situation obtained in banks and other financial institutions.

## Struggle for Pension - United movement in Bank and Insurance planned

In this background, the unions in the financial sector decided to forge unity and launch united struggles to achieve this demand. On 11<sup>th</sup> July, 1990 in Kolkata, representatives of AIIEA, National Confederation of Bank Employees (NCBE), All India Bank Officers Confederation (AIBOC), Bank Employees of India (BEFI), All India Reserve Bank Employees' Association (AIRBEA) and Federation of LICI

## PENSION - A SAGA OF GLORIOUS STRUGGLES

....it is pertinent to trace the history of pension and the struggles led by AIIEA to reach a successful closure on an important demand.

Revision

of DCPS (NPS) One More Ension Option

#### B.S.Ravi

Class I Officers' Association held a meeting to analyze the perspective and justification of the demand of Pension as additional retirement benefit.

The meeting decided to intensify the struggle for pension as third retirement benefit by a program of sustained campaign by all organizations. Thus the struggle on the demand rolled on with commencement of campaign during July-August, 1990. The meeting resolved to form a Coordinating Body of the participating organizations as also those who would be associating with this endeavor. Com. Samir Ghosh, General Secretary, AIRBEA was elected as Convener. Subsequently, All India NABARD employees' Association, National Federation of General Insurance Officers, Indian National Bank Employees' Federation, All India Regional Rural Bank Officers' Federation joined the Coordinating Body to further strengthen the movement for Pension.

In the meantime, the Chairman of LIC wrote an open letter to say that Pension as an additional retirement benefit is not feasible and in the process tried to communicate that this demand is in conflict with the interest of the agents and the policyholders. The AIIEA refuted all the reasons advanced by the Chairman and took strong objection to the way he attempted to disrupt the relations between the employees, agents and policyholders.

#### COORDINATING BODY

#### **DECIDES ON AGITATION**

The Coordinating Body met at Hyderabad on June 28,1991and decided on a series of programs. The Coordinating Body which was subsequently named Joint Action Committee (JAC) representing over ten lakh financial sector employees launched various struggles like All India Demands Day on 7.9.90; state level dharnas on 27.8.91 and central level dharnas on 27.9.91; submission of Memorandum to respective managements; submission of Memorandum to the Finance Minister Shri Manmohan Singh on 19.9.91 and again on 4.10.91; strike actions on 30.4.92 and 29.3.93 were very successfully observed. However, these actions failed to break the ice and JAC decided to go on an indefinite strike in November 1993. This forced the government to finally instruct the managements of the respective institutions to discuss the pension issue with the Unions.

#### **Discussion on Pension with LIC and GIC**

Discussion was held between the Management and the AIIEA on  $1^{st}$   $2^{nd}$  December 1993 and again on 13.1.94 to reach a conclusion. Agreed conclusions on pension were reached in LIC and GIC on  $14^{th}/15^{th}$ January, 1994.

The long and tortuous journey of AIIEA in quest of an effective pension scheme, at last met with success with government notifying the scheme on 28.6.1995 and administrative instructions were issued on 5.7.1995 in LIC.

Introduction of pension benefit itself is a great achievement. What made it even greater were the finer aspects such as:

- i) Retrospective effect from 1.1.1986
- ii) Facility of commutation by families of those who retired after 1.11.93 and unfortunately died
- iii)Family pension for the families of those who retired after 1.1.86 and unfortunately died
- iv)Most important of all, securing the basic pension related to 1148 points of consumer price index for those who retired after

1.11.93 thereby almost doubling the quantum of commutation value. The value and significance of this achievement has to be seen when a union in Banks signed a settlement linking pension to 600 CP index. This singular advancement made the pension benefit an additional benefit, a third benefit in substance.

v)Even for younger employees who did not intend to opt for pension, the introduction of CPF upto 1148 points was a major gain capable of substantially boosting their retiral benefit.

The AIIEA had to struggle to ensure that the mischief played to deny certain benefits are defeated. The debilitating provision 19(4) of the Staff Regulations which made the employees ineligible to receive pension for the period of encashment of privilege leave on retirement, had to be deleted or amended. GTI scheme was demanded by AIIEA for compensating the loss of commutation value if the employee dies while in service. At the fag end of the issuance of notification a clause was attempted to be inserted to ensure that additional liabilities on pension benefit would be subject to availability of fund. AIIEA firmly and decisively intervened both with management and government. As a result a clear provision under Rule 5(3) was incorporated which says - "the Corporation shall ensure that sufficient sums are placed in the Fund to enable the Trustees to make due payment to beneficiaries under these Rules"

The AIIEA reiterated the demand that employees who retired between 1.1.86 and 31.10.93 should also be enabled to have basic pension and commutation value worked out on the basis of terminal basic pay and Dearness Allowance upto the maximum of 1148 points. For employees who retired prior to 1.1.1986 should be granted an ex-gratia relief of Rs.500/- per mensem along with Dearness Relief as provided by the Central Government to its employees.

Thus the glorious struggle for introduction of Pension Scheme to insurance employees concluded with the notification of the scheme on 28.6.1995.

#### Final Option for joining Pension Scheme 1995

Pension Scheme 1995 was notified vide GSR -525(E) dated 28.6.1995. Employees were given option to join the Pension Scheme. The effective date was 1.11.1993. Option to join the scheme could be exercised within 120 days of date of notification. Group Term Insurance Scheme (GTIS '97) was introduced w.e.f 1.2.1997 to cover loss of commutation of pension on death of a pensioner while in service. Last date to exercise option for this scheme was 22.3.1997.

Some employees did not exercise the pension option for the reason that the high interest rates prevailing at that time were more attractive to continue in PF than to opt for pension. Since numbers of employees opting for pension were lower than expected, another option was given to join the scheme during the period 1.5.1997 to 19.8.1997. Even after the second option, a small portion of employees (less than 15%) did not exercise it as they felt that there is no significant change in the prevailing macroeconomic environment in the country.

However subsequent improvements in the pension scheme and the declining interest rates created conditions for the demand for a final option on pension. The inclusion of widowed and divorced daughter and parents who are wholly dependent on the deceased employee; increase in the income limit under 'dependency' clause with indexation facility made pension attractive. The introduction of full neutralization of DA w.e.f.1.8.97 considerably enhanced the pension benefit. The AIIEA, therefore, raised the demand for a final option in the year 2002 and backed up this demand with struggles.

However, the government and the managements of both LIC and PSGI companies were unwilling to grant any more options quoting the financial strain involved. The AIIEA in due course could successfully convince the LIC and GIPSA managements about the legitimacy of the demand and also the financial viability. The LIC wrote to the government on July 24, 2014 requesting approval for final pension option and asserting that LIC can bear the cost. However, the government categorically rejected the positive recommendations of the LIC & GIPSA in December 2016 on the floor of Parliament and in June 2017 through a letter to LIC.

But AIIEA continued its struggle without any respite. This demand was raised vociferously in successive Charter of Demands due in 2002 to 2017. Innumerable programmes were taken up to achieve this demand. AIIEA pursued the issue with LIC Chairman and other top Officials through personal meetings and through detailed representations justifying the

खारिज कर दिया था परन्तु लोकसभा में विपक्ष के नेता श्री खड़गे जो उस संसदीय समिति के अध्यक्ष भी हैं, ने कहा कि ऐसा हुआ ही नहीं है। उनके पास कोई रिपोर्ट आई ही नहीं। उन्होंने कहा कि यह सरकार पर सर्वोच्च न्यायालय को गुमराह करने का मामला बनता है। आपको ज्ञात होगा कि सी.ए.जी. की यह कथित जांच रिपोर्ट बजट सन्न के आखिरी दिन आनन–फानन में राज्यसभा में प्रस्तुत की गई थी।

अटॉर्नी जनरल के.के.वेणुगोपाल ने सर्वोच्च न्यायालय से कहा कि सी.ए.जी.रिपोर्ट दायर करने में चूक हुई है। रिपोर्ट के 3 पेज गायब थे। इन्हें रिकार्ड में लिँया जाये। तब जस्टिस कौल ने कहा कि जिन दस्तावेज पर विशेषाधिकार का दावा है, वे तो कोर्ट में प्रस्तुत किये जा चुके हैं। इस पर वेणुगोपाल ने कहा कि ये दस्तावेज चोरी करके पेश किये गये हैं। इस पर जस्टिस जोसेफ बोले कि सूचना का अधिकार कानून पारित हो जाने के बाद सूचना जगत में क्रांति आड़ है। हमें फिर से उस स्थिति में नहीं लौटना चाहिए। सूचनाएं सर्वाजनिक करने में दिक्कत क्या है? वेणुगोपाल ने कहा कि चोरी दस्तावेज में रफाल की कीमत दर्ज है और फ्रांस सरकार ने रफाल की कीमत उजागर नहीं करने की शर्त रखी है। जस्टिस जोसेफ ने सवाल किया कि क्या यह हलफनामें में कहा है? अटॉर्नी जनरल ने कहा – नहीं। इस पर याचिकाकर्ता अरूण सौरी ने कहा कि मैं अटॉर्नी जनरल को धन्यवाद देता हूं कि उन्होंने हमारे द्वारा दायर दस्तावेज के असली होने का प्रमाण दे दिया। उन्होंने कहा कि दस्तावेज रक्षा मंत्रालय के दस्तावेजों की फोटोकॉपी है। सर्वोच्च न्यायालय में सुनवाई की कड़ियों में मोदी सरकार अपने ही बनाये झूठ के चऋव्यूह में अब खूद फस गई है।

जिन दस्तावेजों को दरअसल वह चोरी का बताकर मामले को गोलमोल करना चाहती है, असल में वहीं दस्तावेज हैं, जो राफेल घोटाले की सच्चाई को देश के सामने रखते हैं। यह साहसपूर्ण कार्य 'द हिन्दु' जैसा निष्पक्ष और आजादी के संघर्ष से तपकर निकला और सन 1978 से निरन्तर जनता की आवाज बना सही अथौं में सच्ची और खोजी पत्रकारिता करनेवाला अखबार ही कर सकता है। उपनिवेषिक काल और आजादी के बाद सरकारी दमन के खिलाफ 'द हिन्दु' का संघर्ष एक मिसाल है। यह एक ऐतिहासिक तथ्य हैं कि 1917 में रोलेक्ट एक्ट के खिलाफ जनप्रतिरोध की रूपरेखा महात्मागांधी की उपस्थिति में 'द हिन्दू' के संस्थापक श्री कस्तुरीरंगन के घर पर ही तय की गई थी। जनसमर्पित इस अखबार ने सच्चे सबूतों को जुटाकर निर्भीकता से उन तथ्यों को सामने ला दिया जो राफेल मुद्दे पर पूर्व दायर याचिका के समय मोदी सरकार ने सर्वोच्च न्यायालय में सच्चाई को छुपाने के इरादे से प्रस्तुत ही नहीं किये थे।

demand. This demand was backed by strike actions. This forced the LIC and GIPSA to once again take up this issue with the government. The AIIEA along with unions in General Insurance met the Finance Minister to impress upon the need to concede this demand. Subsequently the AIIEA met the Secretary and Addl. Secretary DFS on 12.2.2019 with the help of Com T.K.Rangarajan, MP CPI(M) to achieve a breakthrough. The AIIEA, NFIFWI and Federation of LIC Class I Officers' Associations met on 13.2.2019 at Hyderabad and decided on agitation on this issue including a strike action on March 1, 2019. Finally a breakthrough was achieved on  $27^{\mbox{\tiny th}}$  February when LIC informed AIIEA in writing that negotiations on wages will be held soon and there were positive developments on pension. Ultimately, this protracted struggle resulted into a gigantic success by way of Finance Ministry approving the final option to join the 1995 Pension scheme, first through a tweet by FM on March 1and subsequently through an official letter to LIC & GIPSA on 2.3.2019 to all those who could not exercise the option earlier. The success will be more gratifying if it is analyzed in the backdrop of government's economic policy direction and the aggression with which it is proceeding in implementing the neoliberal agenda.

The Gazette notification of Pension Option would have come by the time this magazine reaches the readers. The retired employees would be asked to repay 1.3 times the amount they received as management's contribution of PF & interest. The existing employees would have to pay 3.7 times their current pay to join the scheme. This would bring to a successful close a long standing and important issue.

The closure of this issue brings into focus other issues relating to pension. The AIIEA has already raised the demand for periodical updation and increase in family pension. AIIEA has also raised the demand for scrapping of Defined Contribution Pension Scheme for those joined after 1.4.2010 and extending to them also the 1995 Pension Scheme. The struggle on these issues will continue.

ven at the best of times the inflow of Linternational news leaves Indians cold, barring the news of high profile sport or the final round of American elections. In times such as these, when the people of India are entirely engrossed in the national elections, the news from outside India looks even more remote. Yet, two incidents need mention as they hold up a mirror for us too. One of these two is from Poland where a right-wing national weekly had a front-page story on 'how to recognize a Jew'. The Tylko Polska (Only Poland) detailed methods to be used for identifying Jews by names, physical features, personality traits and more. The story caused disgust and received an appropriate response of condemnation in political circles. It did; nonetheless, the story was there. Surely, as news writers know it well, there were readers who wanted to see it appear. The rise of the right wing in Europe, even in the countries that have not long back faced the Holocaust and the brutalities of Auschwitz, is no longer just an apprehension but a spectre. It is universally known that public memory is short. The other story comes from New Zealand where an Australian zealot has butchered innocent persons, sullying the quiet and amity in that country. The rise of the Right - the spread of violence and hatred, assaults on decency and the decline of democracies — is a phenomenon that has been fast enveloping the world.

During Margaret Thatcher's regime, the conservative British habits of mind made England believe that there would be some let-up in the government's anti-poor policies. That has not happened during the last four decades. After the dismantling of the former Union of Soviet Socialist Republics, many had hoped that Russia would actually become a welfare State prompted by an open society. That hope is dead a good quarter of a century. An economically compounded Europe was initially seen as the transformed future of the nation state, and the brief spell of Eurocommunism was seen as the rebirth of the idea of equality. Far from it; at present nearly a dozen European countries are experiencing a rapid rise of the political right-wing influence. One had hoped that long wars in Iraq, Iran and Afghanistan would end by generating new models of balance of power. Instead, they resulted in spawning the ugly face of militant theocracies and a range of non-State formations thriving on terror and violence. The killing of 17 journalists in Afghanistan in just one year requires no further comment. The world today looks more sordid, far more terrifying and unsettled than ever before. The sphere of influence of the ideas of peace, amity, evenly shared progress, reason, balance and restraint has been continuously shrinking. It is as if, like the great economic depression forming the prelude to the Second World War, there is a kind of a great political depression presenting itself to the community of nations as a prelude for something terrible to come.

The 1980s brought a fleeting vision of the future world as a kind of an extended single nation. Increased food sufficiency, better transport and oil tracking, more easily accessible healthcare and the promise of free flow of information were in the background of the German unification.

In our country, those years were marked with the telecommunications and television revolution. Despotic rules and dictatorships, where they existed, had started looking like expired ideas by the mid-80s. Liberal economic ideas were becoming ready to free the spirit of enterprise and creativity and loosen the stifling regimes, making them supple and flexible. The fear of nuclear wars had started evaporating like some forgotten nightmare. The world thought that the future wars would be wars on malnutrition, disease and illiteracy. International agencies were getting ready to spell out their agendas for the Millennium Development Goals and 'X for All' kind of collaborative programmes. However, through the last three decades the mood has changed, changed altogether and, as W.B. Yeats said a century ago, "a terrible beauty is born".

There is a definition of democracy which quips 'democracy is a rumour not as yet disproved'. In our time, it is indeed becoming only a rumour, in Chile, Russia, the United States of America, Nigeria, Egypt and even in our dear own country. During the last few years, the world over there has been an inexplicable rise of an anti-democratic sentiment. This is explained by Left-leaning thinkers as the capture of the State by the corporate. Gandhians explain this as a predictable consequence of unchecked greed. Neo-liberals explain this as a passing phase of the clash between technocratic ethics -'transparency' and 'fast-growth' - and the political order prone to 'populist' economic drives. There are also explanations stressing the deviant personality traits of individuals, whether Donald Trump, Recep Erdogan or Narendra Modi. What is difficult to explain is why there are so many of them and all at the

same time. George Santayana had described his times as the world 'on a moral holiday'. Following him, one can probably say that the world today appears to be 'on a political holiday'. And that brings me back to the summer of 2019 in India.

Considering the destruction of institutions and the disregard of the Constitution during the last five years, the key words for the Lok Sabha elections should have been 'democracy', 'freedom of expression', 'equality before law', 'Constitution', 'peaceful relations with neighbours' and 'voice of the marginalized'. Instead, most TV channels and many print journals have been over-busy in promoting polarization, machismo and chest-thumping. In spite of the code of conduct, the warcries are still sounding in the background of elections this time. Any war is undesirable; and an armed conflict between two nuclear powers is most scary. The destructive power of their arsenal and the irreparable damage it can cause to life now and for a long time to come cannot even be imagined. The Pulwama attack was absolutely detestable. Like millions of other Indians, I condemn it. But, to use the air-strike on a terror training camp as political fodder is to demean political discourse.

To blame only the political parties would be off the point here. A substantial part of the responsibility goes to all of us, the people, media, intellectuals and activists. If we, as a nation, do not use the elections as our precious opportunity of speaking to the powers through our votes, if we neglect 'writing to the Editor', we too would have failed our precious and already weakened democracy. Hubris, arrogance, false propaganda and lies are the weapons with which the Trumps of the world are trying to bend the idea of democracy. I think it is necessary for the citizenry to refuse to bend and crawl, refuse to brush aside the pain of pauperized farmers and jobless youth. Citizens have to remember that, in spite of the seductive propaganda and intimidating chest-thumping by self-styled superheroes in our public life, our taking a political holiday can send India back by several decades. 
# The twain can't meet

#### Electoral concerns cannot drag armed forces into party politics. The military and elections are separate landscapes and must remain so.

Two incidents, involving politicians and military officials in public, have been in the limelight in the past two months, both gaining visibility due to social media platforms. Both the countries are democracies from the British Commonwealth, which means that the two armies are also similar in their ethos, culture and norms to the Indian Army.

To recapitulate, the first incident happened in Canberra, Australia, where Chief of the Defence Force, Angus Campbell, tapped the defence minister, Christopher Pyne, and asked all the military officers present on the stage to step aside as the minister answered a political question from the Press. The second incident has to do with a video which went viral: It shows four British soldiers undertaking shooting practice in Kabul, using a photograph of Labour party leader, Jeremy Corbyn, as a target. The photographs of various leaders were available with this group of soldiers for training



as "guardian angels" — for close protection and the incident caused a lot of outrage. An initial investigation reportedly failed to find any evidence of links to fascist or far-Right political groups, but the four paratroopers have been flown to Britain to face court-martial for breaking the army's strict disciplinary code.

Meanwhile, here in India, the election campaign season is on and the Army is in the spotlight, forming a major part of the ruling party's campaign agenda. Uttar Pradesh chief minister, Yogi Adityanath, described the Indian Army as Modi's army and got away with a mild rap on the knuckles from the Election Commission. Union minister Mukhtar Abbas Naqvi used the same phraseology a few days later and seems to have gotten away scot-free. Former Army chief and current Union minister, V K Singh went on record taking objection to anyone naming the Indian Army as "Modiji ki Sena", but backtracked a few hours later.

As witnessed during the release of the ruling party's poll manifesto, the major plank of Modi's reelection campaign is a muscular stance on national security, particularly against Pakistan. It has been the cornerstone of his election campaign so far, despite a group of military veterans writing to the President to put an end to the politicisation of armed forces by political parties during the election campaign. Going by the evidence so far, that appeal is likely to fall on deaf ears with even the defence minister, Nirmala Sitharaman, criticising the appeal.

This is not the first time that the armed forces have been dragged into the spotlight during an election campaign. In 1999, the general elections happened in the aftermath of

the Kargil war, where Vajpayee's government was up for re-election after losing the vote of confidence. The then Army chief, General V P Malik, in his book Kargil: From Surprise to Victory, revealed that he complained to Vajpayee about the **BJP**'s election posters that featured the three military chiefs. Vajpayee ensured that it did not happen again. Giving other instances of soldiers being used for electoral purposes by the BJP and its affiliates during that period, General Malik further noted that, "The armed forces were anguished because they were getting sucked into electoral politics as a result of the blatant effort to politicise the war for immediate electoral advantage. At one stage, in desperation, I had to send across a strong message through the media: 'Leave us alone; we are apolitical'."

Times have changed since then. Two decades ago, a serving chief was forced to send the message - "Leave us alone" - but it is unlikely to be repeated by any of the service chiefs now. Even the military veterans arguing for the armed forces to remain apolitical are dragged into controversy, with the focus being shifted away from the real issue of shielding the army from party politics. This cavalier approach seems to suggest that some people are totally unmindful of the detrimental consequences of politicising the armed forces. They have willy-nilly forgotten that the armed forces have to be not just apolitical, they have to be seen as being above all kinds of party politics. The valour of our soldiers is not to be used to procure votes for any party.

#### Armed Forces Officers ask President to stop politicisation of armed forces for election

150 armed forces veterans – including three former army chiefs, four former navy chiefs and a former air force chief – wrote to the President and Commander-in-Chief on April 11, 2019 to complain about the manner in which political parties have been repeatedly using armed forces for political gains ahead of the Lok Sabha election.

The letter urges President Ram Nath Kovind "to take all necessary steps to urgently direct all political parties that they must forthwith desist from using the military, military uniforms or symbols, and any actions by military formations or personnel, for political purposes or to further their political agendas."

The army veterans have said that "some concerns have caused considerable alarm and disquiet among both the serving and the retired personnel of the forces." They have also objected to the use of Indian Air Force Wing Commander Abhinandan Varthaman's pictures in posters, along with the image of soldiers in election hoardings and campaigns.

Here is the letter written by the group of veterans produced in full:

#### FROM A GROUP OF VETERANS TO OUR SUPREME COMMANDER

April 11, 2019

Honourable Shri Ram Nath Kovind President of India and Supreme Commander of the Indian Armed Forces Rashtrapati Bhavan, New Delhi

Dear Shri Ram Nath Kovind Ji,

We, the signatories, are Armed Forces Veterans who have served in the defence of our nation in various appointments, in peacetime and in operational and war zones over the past several decades.

The apolitical and secular nature of India's Armed Forces has been an article of faith for every soldier, sailor and airman. India's Armed Forces have loyally upheld the democratic principle of civil control over the military. Their military professionalism on and off the field, combined with the devotion to duty in protecting India's territorial sovereignty and national integrity, remains widely appreciated.

The soldiers, sailors and airmen of the Armed Forces owe allegiance to the Constitution of India, of which you, as President of the Indian Union, are the legal custodian. It is for this

reason that the President is also the Supreme Commander of the Armed Forces and we serve and execute orders at the will of the President and as decided from time to time by the Executive – that is, the Government of the day.

You would be aware that those in active service (men and women of all ranks in the Army, Navy and Air Force) cannot speak out, even on matters which might affect their interests adversely, since they are subject to military law and are governed by the parliamentary Acts of their respective Service.

However, we Veterans being in continuous touch with our own military fraternity, as also with serving personnel at all levels, have a 'finger on the pulse', so to speak. And it is for this reason that we write to bring to your attention, as the Supreme Commander of India's Armed Forces, some concerns which have caused considerable alarm and disquiet among both the serving and the retired personnel of our Forces.

We refer, Sir, to the unusual and completely unacceptable practice of political leaders taking credit for military operations like cross-border strikes, and even going so far as to claim the Armed Forces to be"Modi ji ki Sena". This is in addition to media pictures of election platforms and campaigns in which party workers are seen wearing military uniforms; and posters and images with pictures of soldiers and especially of Indian Air Force Wing Commander Abhinandan Varthaman, displayed.

We do appreciate that complaints by some senior retired personnel, including a written submission from a former Chief of the Naval Staff to the Chief Election Commissioner, have elicited a prompt response. Indeed a notification has been issued asking for an explanation from those responsible for these statements, including from the Chief Minister of Uttar Pradesh. However we regret to state that these do not appear to have resulted in any substantive change of behaviour and practice on the ground.

With the General elections round the corner, and given the prevailing environment where political parties and candidates seem to be acting in total disregard of the declaration of the 'model code of conduct', we fear that such incidents may only increase as polling day draws near.

We believe that you will surely agree that any such misuse of the Armed Forces established under the Constitution of India and under the supreme command of the President of India, would impinge adversely on the morale and fighting efficiency of the serving man or woman in uniform. It could therefore directly affect national security and national integrity.

We therefore appeal to you to ensure that the secular and a-political character of our Armed Forces is preserved.

We hereby respectfully urge you to take all necessary steps to urgently direct all political parties that they must forthwith desist from using the military, military uniforms or symbols, and any actions by military formations or personnel, for political purposes or to further their political agendas.

This communication is copied to the Chief Election Commissioner of the Election Commission of India for information and action.

## Singing the nation's hope, keeping a people's faith: Politics and Gulzar

Veteran poet, writer and filmmaker Gulzar says the vote is the only power left with the common man, who has otherwise been rendered quite helpless... then he has the last word: It's not a hope but faith. We will survive. The common man will survive.

Gulzar reads aloud one of his recent poems: "Parchiyaan bant rahi hain galiyon mein, apne kaatil ka intekhaab karo; Waqt ye sakht hai chunaav ka (Slips of paper are being doled out in the streets, it's time to vote for your killer; The tough time of elections is upon us).

At a certain moment of anguish and cynicism, he may have penned this dark and despondent image to describe the most significant five-yearly event in Indian democracy but the poet, writer, lyricist and filmmaker firmly believes in exercising one's franchise.

According to him, the vote is the only strength or power left with the common man, who has otherwise been rendered quite helpless.

"There is only one weapon you have if you don't like the system or the government. It's the only way to bring things into action. It can bring about a change, help remove someone from power. You can ask them to go, tell them that you don't want them," he says.

The common man has been his focus in talking about electoral issues in his works. "I have been reacting as a common man right from my first film. I have been expressing myself, not against any individual, not against any party but against certain ideologies or ways of governance and have taken a stand on what has been happening in the society," he says.

For the song "*Haal-chaal theek-thaak hai* (All is well)" in his debut film on youth unrest, *Mere Apne* (1971), he wrote:

B.A. kiya hai, M.A. kiya,

lagta hai wo bhi ainvey kiya, kaam nahin hai warna yahan,



*aapki dua se sab theek thaak hai* (We studied for BA and MA but look back at it as all needless. There are no jobs but otherwise all is well)".

#### Unresolved concern

Almost half a century later, joblessness and unemployment continue to be two of the significant issues in the general election.

"At what speed have things changed," Gulzar asks rhetorically, adding with a tinge of regret, "We could not bring the country to the point where jobs wouldn't have remained a problem any more."

In the same song he writes: Aabo hawa desh ki bahut saaf hai, kaayda hai kanoon hai insaaf hai; Allah miyaan jaane koi jiye ya mare, aadmi ko khoon-woon sab maaf hai

(The country's air is very clean, rules regulations and justice are all in order; God may decide on who lives and dies but man is easily forgiven for all the murders committed). A sharp jibe at the bloodshed and violence that have played out across regimes at various points in time in the nation's history.

Gulzar set *Aandhi* (1975) in the thick of an election campaign, on a chance meeting between a leading politician and her long estranged husband. Purportedly based on the life of the then premier Indira Gandhi, it was banned during the Emergency.

The larger theme of the film may have been the effect of politics on marital relations but some situations and, specifically the song:

"Salaam keejiye aali janaab aaye hain,

ye paanch saalon ka dene hisaab aaye hain" (Greet the lord and the master who has come to give account of his past five years)" is all about how politicians court the common man and come calling only once in five years and then conveniently forget him.

#### **Cynicism of politics**

The celebrated Bollywood veteran talks cynically about how politicians buy votes by granting something as basic as food and hide the naked bodies of the poor by offering them shrouds:

Hamaare vote khareedenge, hum ko ann de kar, ye nange jism chhupaa dete hain qafan de kar".

But he ends up underlining the significance of vote and has the electorate declare in the song that it won't vote needlessly and will figure out the politicians during the elections by weighing in on the revolutions they have supposedly rung-in during their term:

Ye vote denge magar, ab ke yun nahin denge; Chunaav aane do, hum aapse nipat lenge; Ke pehle dekh lein kya ingalaab laaye hain."

Two of his films have been set in an electionless world. There was an immense sense of loss in his *Maachis* (1996), that played out in the democratic vacuum of a militant Punjab, much like Vishal Bhardwaj's Kashmir- based *Haider* (2014) for which Gulzar wrote the lyrics.

"How could one do what happened in 1984, how can one justify what happened post Godhra in Gujarat? How could we digest them? It's like politicians were playing chess and the ones who suffered were common people," he says.

For him the turn of events in both the States reflect a sort of dictatorship, emergency, a pushing of governance down the throat of people without their consent. Whereas it should be the people who should have the right to decide, as they do every elections, he asserts.

A sense of "desperation", as he puts, underlined the politics in his last film as a director, Hu Tu Tu (1999). The narrative and songs, both acquired an urgency, feverishness and a direct, street theatre idiom.

A lot of issues he touched upon twenty years ago resonate in these elections as well. Like corruption in "*Ghapla Hai*" and the plight of farmers in the song "*Bandobast*" where he warns against burying and silencing those born of the soil: *Jo matti mein ugte hain*,

#### unko dafna ke kya hoga

Gulzar is almost like the *chowkidar*, nay keeper of the nation's conscience in the song *"Jaago jaago jaagte raho"*. He talks of religious divisiveness and crisis of faith in the song:

Log bant-te hi khuda bantne lage hain; Naam jo pooche koi darr lagta hai, ab kise pooje koi darr lagta hai (With the divisions amongst people, the Gods have also started getting divided; One is scared of uttering one's own name and of worshipping anyone)."

In the song *"Jai Hind Hind*" he again comes back to the issue of unemployment:

Par bhookh meri, bimari meri Jaati nahin kuun bekaari meri

According to him it's the environment and his own sensitivity to the politics around him that reflects in his writing: "The words can't be meaningless. They can't be in a vacuum".

And then goes on to reciting another one of his recent verses about how the electorate has been left completely at the disposal of the government to the extent that it has stopped to think and rationalise about its own self:

Mera ahwal kya maaloom ab mujhko, sunoo TV pe khabrein to bataoon; Wahi hoon jo meri sarkar rakhti hai

(How do I know about my own condition. I will figure when I see the news on TV. I am how my government keeps me).

Gulzar feels India can't be anything but democratic, diverse and inclusive. The big danger is that of divisive politics. He then quotes another one of his poems where a line talks about how it was good to have let her remain on the canvas because had she been drawn on the land, another partition would have happened:

Wo tan ke seedhi khadi thi; akeli thi magar kuchh kah rahi thi line canvas par. Bahut achcha kiya canvas par rehne diya mujhko;

zameen par kheenchte to

phir se koi batwara ho jaata".

But he is hopeful that 10,000 years of recorded history and civilisation can't be wiped away, least of all by avaricious politicians. In his poem "Ye Bemaani Ghaas (This Useless Grass)" he compares the common man to the grass that may be squashed and crushed but manages to still grow from the tiniest crevice it can find in a rock.

Maaro, kooto, katl karo, ya phoonk do inko; Logon mein zinda rehne ki

la-matnaahi taaqat hoti hai

(Whether you beat them, pound them, murder them or set them on fire; people have a great will to survive).

And then has the last word:

Ye meri ummed nahin, yakeen hai.

It's not a hope but faith. We will survive.

jight wing extremism struck once again, on K15<sup>th</sup> March 2019, when an armed gunman opened fire indiscriminately, on the innocent unsuspecting Muslim worshippers, while they were offering Friday noon prayers, first at the Al Noor Mosque and later at Linwood Islamic Centers in Christchurch, New Zealand killing 50 people and injuring as many others. 7 of the dead are of Indian origin. One of them was the son of a former LIC employee. The victims include women and children. Many of the victims are migrants and refugees. The attacker live-streamed the first attack on Facebook for 17 minutes. The incident shocked the entire civilized world and the brutal massacre received universal condemnation.

The police reacted promptly by stopping the assailant from proceeding to a third target location and arrested him within 21 minutes from receiving the first emergency call. The police identified him as Brenton Harrison Tarrant, a 28 year old Australian, who described himself as an alt-right white supremacist, an eco-fascist and an ethnonationalist. He was charged with murder and taken to custody. The attacks have been linked to an increase in white supremacism and altright extremism globally observed since the mid-2010s. It was revealed that the attacks were planned two years in advance and the targets were also chosen three months back. The culprit allegedly posted a hate filled racist "manifesto" on social media, minutes before the attack and e-mailed it to 30 recipients including the Prime Minister's office and several media outlets.

The reaction of the New Zealand people, to this dastardly act, has been heart touching. They stood as one in the hour of crisis. The mosques involved in the attacks, and others around the country became the focus of vigils, messages and floral tributes. Across the world, marches took place during a UN anti-racism day, condemning the attacks. In cities across New Zealand, people gathered at prayer services and vigils to honour victims of the terror attack. People from all religions laid flowers outside the city's Botanical Gardens as a mark of sympathy and solidarity. School pupils and other groups performed 'Haka'and 'Waiata' (traditional dances) to honour those killed in the attacks.Street gangs sent members to mosques around the country to help protect them during prayer time. One week after the attacks an open-air Friday prayer service was held in Hagley Park. Broadcast nationally on radio and television, it was attended by 20,000 people, including Prime Minister Ardern who said "New Zealand mourns with you. We are one." The imam of the Al Noor Mosque

thanked New Zealanders for their support and added, "We are broken-hearted but we are not broken".

The New Zealand's prime minister, 'Jacinda Ardern' showed the world what real leadership is by her extraordinary exhibition of "sympathy, love and integrity" in the wake of these attacks. In a press interview on 16.03.2019, she said "We, New Zealand, are targeted because we represent diversity, kindness, compassion, a home for those who share our values, refuge for those who need it. And those values will not and cannot be shaken by this attack. We share common values and the one that we place the currency on right now and tonight is our compassion and the support for the community of those directly affected by this tragedy. The strongest possible condemnation of the ideology for those who did this ... we utterly reject and condemn you".She further added that the culprits had "extremist views that have absolutely no place in New Zealand and, in fact, no place in the world".

Prime Minister Jacinda Ardern scored a powerful victory against terror simply by refusing to say the Christchurch attacker's name. In a speech before parliament on 19thMarch, she said she would never speak the name of the 28-year-old Australian man charged with the crime. She told the parliament "He sought many things from his act of terror, but one is notoriety. And that is why you will never hear me mention his name. He is a terrorist. He is a criminal. He is an extremist. But he will, when I speak, be nameless. And to others, I implore you: Speak the names of those who were lost, rather than the name of the man who took them". "We, in New Zealand, will give him nothing. Not even his name," Ardern added. Thus Jacinda Ardern's decision not to name the perpetrator of the attack offers

a blueprint on how to deal with terrorists—by deflecting the attention from the perpetrators towards the victims.

It may turn out that the extremist who committed this attack acted alone, but the ideology that motivated him has spread around the globe and is infecting our politics and discourse. It is part of a larger trend of resurgence of the radical right which is being ideologically supported by many governments across the world. According to research by the Anti-Defamation League, over the last decade, 73.3% of all extremist-related fatalities in the US could be linked to domestic right-wing extremists, while 23.4% were attributable to Islamist extremists. It is a tragic reality to note that globally Muslims have been by far the most victimized group by terrorism in the post-9/11 era. As some statistics on attacks on minorities show, there has been a rise in targeted attacks on the Muslims by 65 % in Britain in the last one year. Of the 7175 hate crimes reported in 2017 in the USA, 18 % were religious in character, the Arab and Muslim Americans being the main targets. In Canada, the hate crimes against Muslims, Jews and Blacks have gone up by 47 % over the last one year. The European Islamophobia Report 2017 revealed 81 attacks against mosques and 908 crimes against German Muslims. The Second European Union Minorities and Discrimination Survey, 2017 expressed a much more generic systemic violence where Muslims were discriminated at work place, public places and faced physical assault. Clearly, there is imperative need to focus more tightly on the ideology of fascism, which underpins both right-wing groups and those who commit violence in the name of Islam.

Prime Minister Jacinda Ardern was praised world over for her mature response to



the attack. She showed the world what real leadership is, by her extraordinary exhibition of "sympathy, love and integrity". She vowed to renew efforts to counter right wing extremists whose politics had led to the targeting of Muslim worshippers. She received a standing ovation at the national remembrance service held on 29 March, a fortnight after the attacks at the Hagley Park. Addressing the crowd of thousands, she said "What words capture the anguish of our Muslim community being the target of hatred and violence? I thought there were none. And then I came here and was met with this simple greeting. Assalaam Alaikum (Peace be upon you). They were words spoken by a community who, in the face of hate and violence, had every right to express anger but instead opened their doors for all of us to grieve with them. And so we say to those who have lost the most, we may not have always had the words. But, even when we had no words, we still heard yours, and they have left us humbled and they have left us united. But with that memory, comes a responsibility; a responsibility to be the place that we wish to be. A place that is diverse, welcoming, kind and compassionate. Those values represent the very best of us. We are not immune to the viruses of hate, of fear, of other. We never have been. But we can be the nation that discovers the cure. And so to each of us as we go from here, we have work to do, but do not leave the job of combating hate to the government alone. Let that be the legacy of the 15th of March. To be the nation we believe ourselves to be. We will remember the tears of our nation and the new resolve we have formed".

The swift response by the New Zealand government, has however not been matched by its Indian counterpart, even though the Modi government made customary noises about shock and sadness at the attack. In a cautiously worded statement, the Indian government "condemned terrorism in all its manifestations", but had a deafening silence on the question of targeting the Muslim worshippers. This silence must also be seen in the context of the Pulwama attack where the government was quick to use it for its own political ends, but took almost one week to even acknowledge that Kashmiri Muslims were being targeted by the right wing Hindutva extremists in the wake of these acts. This makes it clear that the attitude of the union government does not treat "all forms of terrorism" by the same yardstick.

The implicit support for the right-wing non-Muslim extremism by the government is already witnessed in the cases of the lynching of Rakbar Khan in Nuh, Mohammed Akhlaq in Alwar, Afrazul in Rajsamund, Junaid in Ballabhgarh and the rape and murder of 8 year old Asifa in Kathua. While the country continues to face similar instances of targeting, the anti-minority and more specifically, the anti-Muslim rhetoric is even far more virulent, especially in the wake of the elections. The strident cultural nationalism of the Sangh Parivar has found its expression in the policies of the government, the most blatant of which has been the lapsed Citizenship Bill. The right wing election campaign is largely centered on being patriotic, which in terms of the BJP means being 'pro-Hindu'. The political regime has not only supported but also rewarded anti-Muslim rhetoric and activities.

The explicit manipulation of the law enforcing agencies to benefit the accused of the majority community leading to their eventual acquittal in the 'saffron terror cases' has increased the feeling of insecurity as well as Islamophobia in the country. Though, such Islamophobia is not new, its penetration into

> daily lives of the Muslims has reached new proportions. All democratic forces are facing a challenge to address the growing alienation as well as addressing the current insecurity of the minorities. A first step towards this can take place if all unite to strengthen the left, democratic, secular forces and defeat the rightwing machinations in the 2019 elections.

## Jammu: Convention on Unemployment

Speaking on the occasion, Com. Bhatnagar said that during rule of NDA Govt., the rate of unemployment has gone to the highest at 7.2% in the last forty five years; and in case of youth, this rate is nearly 16%. The reason behind this is the demonetization and also the implementation of GST in haste without proper preparations. In 2020, the average age of an Indian will be 29 years and the increasing rate of unemployment is going to be a big challenge for the youth of the country. As per report of 'Centre for Monitoring Indian Economy', more than one crore people have lost their jobs in the last years. So this jobloss has been a big concern and it has been leading to suicides by many youths. He said that total number of employees in the central government dipped to 32.53 lakhs in 2017 from 33.28 lakhs in 2014, a loss of 75000 jobs. In over 330 central public sector enterprises which employed 16.91 lakh persons in 2014,the 2017 figure is15.24 lakh,a loss of 1.67 lakh jobs. The jobs in public sector banking sector also came down from 9.47 lakhs in 2015 to 9.12 lakhs in 2017, a loss of 35000 jobs.

Sh. Raqeeq Ahmed Khan, youth student leader, President of National Student Union of India J&K said that promise of the BJP Govt. to provide two crore jobs per year has totally fallen flat..Com.Om Parkash said that there are 60 lakh unfilled vacancies in government posts. The convention was also addressed by Com. Anil Vaid, General Secretary Bank Employees Federation of India J&K. and by Com. Madan Gopal.

In his mesmerizing speech, Dr. Satyaki Roy introduced that for the first time since independence, the Government has made National Sample Survey non-functional lest the data reveal the reality of unemployment in the country, which is presently the highest since the last 45 years. He explained that growth of the economy at a higher rate than that of employment implies that the labour force is being increasingly exploited. He narrated that since the economy is financialized, the profit of the entrepreneur is increasing but employment is decreasing. He exemplified by saying that while an investment of one crore rupees in 1970 enabled employment of 400 persons, the same investment would now employ merely 4 persons. He clarified that the neo-liberal globalization is keen on the advent of capital intensive technology, replacing labour intensive ones thereby casting a gloomy shadow on employment in an over-populated country like ours.

Dr. Roy highlighted that in our country, rate of unemployment is increasing with increasing level of education and expertise. While rate of unemployment is 2% among illiterates, it is 16.4% among

graduates, post graduates and professionals. He lucidly analysed that though an illiterate worker has no precondition regarding working environment and wages, a qualified worker has naturally certain expectations and inhibitions leading to wide scale depression among the unemployed educated youth.

Dr. Roy mentioned that there has been a major shift in the employment pattern since the last three decades during which the agricultural workforce has decreased from 68% to 49%. Though this may seem to be an indication of development, 86% of the population dependent on agriculture is unable to provide their means of subsistence. Despite a huge workforce being absorbed in the informal sector, 79% of them do not have any job agreement entailing job security and 72% are devoid of defined retirement benefits. Being a sincere disciple of neo-liberal ideology, the Government firmly believes that these staff amenities are really superfluous. He further warned that artificial intelligence, the modern version of technological development, is proving to be a curse for a labour intensive economy like ours, threatening the removal of 69% of existing jobs in our country.

Dr. Satyaki Roy concluded with an assertive note that this evil ploy of capitalism should be resisted by the progressive forces campaigning for an alternative agenda through struggle and movements among the masses. His eloquence has left the spellbound audience in a jampacked auditorium determined to go ahead to achieve the cherished goal.

## Com. Amanulla addresses Seminar at Gauhati

'After attaining Independence when India embarked upon the path of Industrialization and a self-reliant economy it had no choice but to rely on public sector as the big capitalists of the country neither had enough capital to build up the infrastructure that could lay the basis of autonomous industrialization, nor any eagerness to invest in areas where the gestation period was too long. Public financial sector including the public sector banks and insurance mobilized the savings of the people and provided the much needed resources for nation building. Public Financial Sector acted as one of the strong pillars of national self reliance and sovereignty. Under the Modi regime which has been pursuing aggressively the neo-liberal economic policies this important sector is sought to be dismantled. The serious challenge that the public financial sector faced today became obvious when the Prime Minister himself publicly stated that the bank nationalization was a fraud '- said Com. Amanulla Khan, President All India Insurance Employees Association (AIIEA) while addressing a Seminar at Sudmerson Hall, Cotton University, Guwahati. The Seminar on the subject, 'Public Financial Sector- Its Importance and Challenges' was organized by the Gauhati Division Insurance Employees Association (GDIEA) on 17th March. In his hour long illuminating discourse Com. Amanulla pointed out the enormous contributions made by the public sector Insurance particularly LICI and Banks towards the infrastructure development of the nation and at the same time providing safety and security to the savings



of the people. He lambasted the neo-liberal economic policies pursued recklessly by the present regime which cater to the interests of the international finance capital and the big corporates at the expense of the public financial sector and the public sector as a whole. He said that under the present ruling dispensation the corporate loot of people's savings in the PSBs had reached an unprecedented dimension. NPAs most of which belong to the big corporate have registered an alarming rise. Bank frauds by corporates shot up at a menacing rate in the last three or four years. Many of these corporate bosses have left the country. Modi regime instead of taking stern action against these defaulters has written off more than three lakh crores of rupees of bad debts of corporates while it refused to write off a single penny of debt of the peasantry . These write offs have been given the name of 'hair cut'. As a result PSBs today are faced with serious crisis that is impacting the economy

## **Crisis of Joblessness : Seminar at Ranchi**

A seminar was organized by **Insurance Employee's Association Jamshedpur Division** and **Insurance Employees Association Hazaribagh Division** at Ranchi, the capital city of Jharkhand on 17<sup>th</sup> March 2019 (Sunday) on the subject "NEOLIBERALISM AND CRISIS OF JOBLESSNESS IN INDIA".

The seminar commenced with the placement of an approach paper on the captioned subject by com. Manoj Minz Asst Secretary, IEAJD, the CONVENOR of the convention.

**Prof. Dr Ramesh Sharan, the Vice Chancellor of Vinoba Bhave University, Hazaribagh (Jharkhand)** and a renowned economist inaugurated the convention. He vividly explained the principles of Neoliberalism and the crisis of unemployment. According to him the issue is very important and relevant since the adoption of LPG policies by the world; it not only created great difficulties in the life of common people but also promoted unemployment. Prof. Saran detailed the preindependence economic scenario and the capitalist exploitation by the then British colonialism. Although the constitution we adopted is a socialistic constitution, but still fundamental rights are not implemented properly. The process of land reforms is not functional even after 70 years of independence. Three/Four states under the rule of left front





adversely. He also sharply criticized the policies of disinvestment of PSGI companies. He underlined that these policies were posing serious challenges to the very existence of public financial sector. The corporate circles and several spokesmen of the government itself have been raising the clamours for privatization of PSBs and public sector Insurance. Com. Amanulla called for mobilization of public opinion in defense of the public financial sector and intensification of the wider united struggle of the working people for reversal of the neo-liberal policy frame-work. He also criticized the imposition of GST on Insurance premium at a steep rate which has been adversely affecting the insurance business and asked for its repeal. He informed that AIIEA would write to all major political parties to include this issue and defence of public financial sector in their election manifestos. Com. Amanulla also refered to the important breakthrough made by AIIEA recently in LICI

implemented it seriously. He criticized the Licensee Raj which helped Capitalists and big Industrialist to acquire more wealth. He described public sector as back-bone of our national economy, praised for its continuous contribution for development of Nation and generating employment. He criticized the policy of CONTRACTUALISM AND CASUALISM, no social security for unorganized labourer and huge vacancies in government jobs including 2 lacks vacancies in different universities.

Com, Pradip Kumar Mukherjee, president ECZIEA & Vice President AIIEA who was the guest of honor, informed the house about the importance of organizing such conventions. Joint secretary, AIIEA & General Secretary, ECZIEA Com. Shreekant Mishra was the chief speaker of this convention. He placed the subject elaborately. He said that the NEO LIBERAL policies are responsible for the present crisis. Com. Mishra criticised the present Govt. for promoting the private capitalists. He dealt at length on the job on the issue of final option for pension, wage revision and recruitment. He said that the tactics adopted by the last AIIEA secretariat meeting had yielded the desired result and called upon the employees to prepare for further struggles for a satisfactory settlement of wage revision.

Nitya Bora , Editor of the largest circulated vernacular daily of Assam , 'Asomiya Pratidin' in his brief address to the Seminar called for ouster of the present regime in the ensuing election in the interest of the Public sector and democracy in the country. Sri M.R.Sahu, Sr. Divisional Manager, LICI Guwahati Division also spoke in the Seminar.

More than three hundred employees of Insurance, Bank and other sectors attended the Seminar which was presided over by Satanjib Das, President, Eastern Zone Insurance Employees Association. In his presidential speech Com. Das called upon the employees to intervene in and influence the public discourse in the run-up to the lok sabha election by focusing on the basic issues of lives and livings of the common people and the public sector vis-à-vis the policies pursued by the present regime . He said that it would be suicidal to shy away from politics as politics determine our lives and the future of our public sector institutions as well as the economy. If politics determine our lives, let us also determine the course of politics, he said.

Earlier Com. Bhabendra Kumar Kalita , Vice President ,EZIEA explained the objectives of the Seminar which began with a couple of chorus performed by the cultural troupe of GDIEA.

It is therefore necessary for democratic, progressive sections and workers to come together to fight the neoliberal policies and protect the public sector financial institutions.

Com Satanjib also pointed out that the Modi government is weakening the secular fabric of the country and systematically crippling the democratic institutions. The opportunity presented by the General Elections should be utilised to expose these policies and defeat the forces that are dividing the people. It is also the responsibility of the workers to help strengthening of the Left and Democratic forces who stand by their struggles.

The other speakers from the  $12^{th}$  July Committee spoke in agreement with the submissions made by Com Satanjib.

## **Insurance News in brief**

LIC grows at the rate of 5.68 percent for the year at the end of the financial year 2018-2019. The Indian life insurance sector has grown at the rate of 10.73 per cent. Garnering a total first year premium of .142191.69 crore, LIC has captured 66.24 per cent of the market share. In the first year premium segment amongst the private insurers HDFC Life tops with a market share of 6.97 per cent followed by SBI Life whose market share is 6.42 percent. During the same period in the segment of number of policies, LIC's market share stands at 74.71 per cent as it has procured 21433256 policies.

SBI Life which stands 2<sup>nd</sup> with a market share of 5.32 per cent which is followed by HDFC Life whose market share is 3.47 percent.

In India Non Life insurance grew by 12.91 per cent with grossing a premium of .150662.09 crore. Four Public Sector General Insurance companies' market share with a premium of .68719.91 crore is 40.40 per cent. While New India stands 1<sup>st</sup> with a market share of 14.06 per cent, United India's market share of 14.06 per cent, United India's market share is 9.63 per cent and National Insurance's market share is 8.92 per cent. Private Insurer ICICI Lombard follows these three Public sector companies with a market share of 8.52 per cent, followed by public sector Oriental General Insurance with 7.79 per cent.

India Bulls Integrated Services, whose life insurance company Indiabulls Life Insurance had received approval from IRDA in January 2019, now gets approval for a general insurance company Indiabulls General Insurance Company.

IRDA notifies that the percentage of business that general insurers in India have to cede to the country's national reinsurance company, General Insurance Corporation of India (GIC Re), for 2019-2020 will remain at 5%.

IRDA has directed general insurers to withdraw the automatic extension in period clause, which is offered as an add-on with annual policy covers such as Stan-dard Fire Special Perils, Indu-strial All Risks, Office Package, Home Package, Shop Package. It, however, has allowed the existing policies to remain in force, wh-ich have been issued under the same clause until their expiry. Listen to what a member of IRDA, Sri.Nilesh Sathe, has to say !. "The onus to deepen insurance penetration in India does not solely rest with the insurance regulator and the insurers. It rests with the government also. High goods and services tax (GST) on

premiums is detrimental in improving penetration. With low social security provisions happening or possible in India, charging 18 per cent GST on premiums is brutal. The government must also allow separate tax breaks for pension products of insurance companies, in line with the Rs 50,000 separate head created for the new pension scheme".

A directive from IRDA has been issued to share the status of claims at various stages of processing to ensure a fair and transparent claim settlement process. In case of health insurance claims, where third party administrators (TPAs) are involved the insurance companies have to make sure that the status of the claims are notified at every stage. The directive also makes it clear that no other unsolicited information can be sent to the policyholder.

Across the globe there is an abundance of innovate solutions and services being offered by many Insurtech companies. The challenge for both insurers and insurtechs is to get a correct match. Hannover Re has launched an innovative pool called "hr | equarium" which aims to connect insurance clients with insurtech partners. hr | equarium provides insurtechs and other innovative players with an open, free-of-charge platform that allows them to pitch their solutions directly online.

There has been a continuous increase in vehicle thefts in UK. According to Association of British Insurers motor insurers pay a  $\pounds$  1 million every day !

The member of the World Bank Group, International Finance Corporation (IFC) has joined hands with Africa Re to help small holder Nigerian farmers to easily access insurance to protect their crops and livelihoods. IFC's and Africa Re's specific support to insurance companies includes helping them design specialized insurance products and develop digital platforms so farmers can easily view and compare index insurance offerings from various providers.

According to Munich Re AG the recent spate of extreme weather events have proven expensive for insurers. Natural catastrophes have cost the industry \$80 billion in 2018.

#### STOP & SHOP SUPER MARKETS WORKERS STRIKE AT OVER 240 SUPER MARKETS IN NEW ENGLAND (US)

More than 31000 Super Market

workers in 3 Southern states remained on strike for a fourth day. They were on strike since 11<sup>th</sup> April. The strike is the largest in the retail industry since 2003 and the second largest private sector walkout since 2016. The strike comes on the heels of an upsurge of workers both in the US and internationally, including a wave of teachers walk out in the US over the past year, the strike of MHQVILADURA workers. In Matamors, Mexico, and the ongoing nationwide walkout by over 3 lakhs teachers in Poland. The present strike actions at STOP & SHOP are against the proposal by management that attacks wages, health insurance, pension benefits. The workers contract expired on 23<sup>rd</sup> February 2019.

#### PROTESTS IN ARGENTINA OVER GOVERNMENT ECONOMIC POLICIES

Tens & thousands converged on the Argentine capital Buenos Aires on April 4<sup>th</sup> to protest the Government's Anti worker economic policies. Protestors marched through pouring rain. Protestors denounced 56 billion IMF loan which has imposed more austerity and hardship on the already struggling workers and the poor. They demanded an end to attacks on Social programs.

#### PARAGUAYAN TEACHERS, PARENTS, STUDENTS PROTEST OVER UNFILLED POSITIONS

Protests that began on March 28<sup>th</sup> at more than 20 schools, in the city of Paraguayan are continuing. As teachers, parents & students press their demand that unfilled positions at their schools be filled. The protestors are also demanding the resumption of works that have stalled.

#### ECUADORIAN POLICE ATTACK PROTEST BY HEALTH WORKERS OVER FIRINGS

Hundred of former workers for the Ecuadorian Health System held a protest on April 4<sup>th</sup> at the Plaza of the Carondelet Palace. The seat of Government in Quito, the protesters were a part of over 2500 Public Health Workers who were fired in early March as a result of closures and reductions of staff at Public Health, Education and Transport Offices throughout Ecuador.

#### GUYANA - ONE STRIKE BY SUGAR CANE WORKERS END, ANOTHER BEGINS

A strike begun on March 27<sup>th</sup> by Sugar cane harvesters over pay and working conditions at the BIAIRMONT ESTATE in Guyan ended on 4<sup>th</sup> April. On the same day on 4<sup>th</sup> April Rose Hall Workers at the Albion Estate walked off the job. About thousands of these workers held a protest in front of the Rose Hall Estate. Workers have said nearly drop 60% of their wages since one year.

## **Working Class Struggles**

SOUTH AFRICAN GOLD MINERS LONG RUNNING PAY STRIKE

Gold Miners at South Africa's Sibanye Stillwater Mines decided to continue their pay strike at a mass meeting held on 10<sup>th</sup> April in the face of legal threats. Despite having lost four & half months wages, 15000 workers are on strike demanding increase in wages and better service conditions. The workers are now facing the danger of their strike being called illegal.

#### GREEK TEACHERS STRIKE

Greek Secondary Teachers are held 24 hour strike on 12<sup>th</sup> April against Government policy on education system. Teachers & students fear the changes will increase the pressure on students & teachers. Rallies were held at Athens & other major cities.

#### DUTCH OIL REFINING STRIKE

Workers at the Shell Pernis Oil Refining in the Dutch city of Rotteroam Struck work on 8<sup>th</sup> April. The refinery is Europe's largest and produces more than 400000 barrels a day. Union members are demanding 5% pay hike. The Shell company offered 2% wage hike.

#### LONDON UNDERGROUND RAIL STAFF/WORKERS ON PAY DISPUTE

Workers on the London Under Ground(LU) tube system have rejected the Employer's 2.5% wage offer. The 10000 Rail, Martime and Transport Union(RMT) members are on strike action. The Pay deal was also rejected by the TSSA Union which represents White Collar Staff working for LU. The LU Management have refused to look other demands for shorter working week and better travel facilities.

#### RUSSIAN FOOD WORKERS WORK TO RULES

Responding to plans by FORD to close 3 of its four plants in Russia, workers at FORD's VSEVOLOZHCK PLANT, in Leningrad, began a work to Rule from 8<sup>th</sup> April. Hundreds of workers in the plant met on 5<sup>th</sup> April voted to strike action

#### ELECTRIC POWER GRID STAFF IN NORTHERN IRELAND HELD STRIKE

Managers & Engineers working for system operator for Northern Ireland held strike on 15<sup>th</sup> April. The protestors demanding a pay increase.

#### STAFF AT UK LONDON BUSINESS ENERGY AND INDUSTRIAL STRATEGY OFFICE STRIKE FOR LONDON LIVING WAGE

Catering staff working for ARAMARK at the Department of Business, office in West Minster, London held 3 day strike from 8<sup>th</sup> to 10<sup>th</sup> April. They were demanding London Living Wage of 10.55 Pounds an Hour

#### **Economic Tid Bits**

#### ■ J.SURESH, MYSORE

\*According to a new agreement, European Union (EU) 27-member States have agreed to a plan allowing UK time up to May 22 to complete the process of Brexit. This followed the discussions between UK Prime Minister Thresa May and the EU Commission President Jean-Claude Juncker. Any further extension would involve UK participation in Elections to the European Parliament which begins on May 22. According to a report published by Huffington Post UK, local councils across UK are selling off assets in property and land worth more than 9 billion pound over the last five years. The mass sell off of public assets has been ramped up due to severe austerity measures imposed by the Central Government in the wake of 2008 crisis. Analysis of the data found that 381 million pounds of these proceeds was used to further facilitate further budget cuts by councils, with 1/3<sup>rd</sup> of this sum (115 million pounds) used to finance redundancy payments. Since 2010, more than 1 million jobs are lost in public sector. In London, Harringay Borough Council sold of 30 properties to raise 35.7 million pound between 2014 and 2018, including two community centres to a private property developer. Local councils face a desperate financial squeeze, with some beginning to collapse financially. Local authorities have seen their budgets reduced by 60% since 2010 as part of austerity measures.

\*IMF Managing Director Christine Lagarde, in a speech ahead of IMF's annual meeting warned that the prospects for the world economy were "precarious". This year she said 70% of the world economy to experience a slowdown in growth. The reality is that many economies are not resilient enough. High public debt and low interest rates have left limited room to act when the next recession comes, which inevitably it will, she said. The latest report of WTO also points out significant slowdown in global growth. In 2017 trade growth stood at 4.6% and in 2018, trade had underperformed with growth of 3% and it is expected to grow at 2.6% in 2019. The slowing of world economy is most pronounced in Europe, where manufacturing indexes, regarded as reliable indicator of the state of the economy, dropped sharply in March. The Purchasing Managers' Index (PMI) for the euro zone fell to

47.5 % from 49.3% in February, a level below 50 indicating contraction. The most significant downturn is in Germany, the biggest economy of Eurozone where PMI dropped to its lowest point in seven years. The IMF in its world economic outlook has lowered its global forecast for growth for 2019 by 0.2% and revised its prediction from 3.6% in January to 3.3% now for the current year.

\*In Australia, the unemployment in February fell by 0.1% points to 4.9%. Australian Bureau of Statistics (ABS) employment survey however understate the real level of joblessness by counting anyone who has worked for one hour a week as employed. A more reliable job survey conducted by Roy Morgan research put unemployment for February at 9.6%, almost twice the official rate. Under employment - people in part time work and looking for more work - stood at 8.6%. That means around 2.5 million workers or 18.2% of the workforce are either jobless or under employed. Unemployment rate for 15-24 age group stood at 11.1% in February, more than double the overall ABS unemployment rate. According to a survey by charity groups the Brotherhood of St. Laurence, around a guarter of a million young people are without work.

\*Mozambique is a nation of acute social contrast. With a population of nearly 29 million, it is the 16<sup>th</sup> richest country in Africa and among the most socially unequal in the world. According to a report by New World Wealth, a market research firm based in Johannesburg, South Africa, there are 1100 millionaires residing in the country. Of this, 50 individuals hold wealth totalling over \$ 10 million. However, according to a world bank report, 60% of the population lives in extreme poverty, with 80% left unable to afford food daily to maintain proper health. The majority also subsists on less than \$2 a day. Mozambique holds vast economic resources in oil and gas reserves and mineral deposits of marble, bentonite, Coal, gold, bauxite, granite, titanium and gemstones. The World Bank estimates that Mozambique holds untapped oil and gas reserves totalling over \$100 trillion and the county has the fourth largest reserves of natural gas in the world.

LIC is the walker: Finance ministry arm Dipam (Department of Investment and Public Asset Management) is trying to depend less on the likes of LIC for public sector undertaking (PSU) share sales. An investment banker has

commented on this: "An IPO without LIC support is akin to a baby trying to walk without a walker. You are bound to fall," he said.

**LIC is Important**: The committee set up by insurance regulator IRDAI to identity domestically Systematically Important Insurer (SII) and put in place an enhanced regulatory framework for such institutions is likely to identify Life Insurance Corporation (LIC) as an SII in the sector. SIIs are perceived as insurers that are 'too big to fail'. "The continued functioning of SIIs is critical for the uninterrupted availability of uninterrupted insurance services to the real economy," it said recently.

**MDRT**: In 2014, India was second in the list of countries having the most number of elite insurance agents. Four years later, it has dropped to sixth position, with number of Indian agents in the Million Dollar Round Table (MDRT), falling 61 percent to 2,892 (as of July 1,2018). But, in the case of LIC, it is steadily increasing.

**Genuine customers pay:** Unarguably, the biggest impact is the fact that the cost of a fraudulent claim may be paid by other policyholders. This is due to pooling of risks in insurance, as the protection costs increase with increasing proportions of frauds. A growing number of frauds also calls for tighter controls and underwriting that leads to delays in policy issuance as well as claim settlements.

**Claim in Installments**: IRDAI had set up a working group to study a proposal in this regard and the panel had submitted its report in January this year after examining the concept of settlement of personal accident and benefit-based health insurance claims in installments. Now, the insurance regulator has come out with draft guidelines and sought comments from stakeholders. The draft guidelines said the policyholders may be provided an option of choosing either settlement of claim in lump-sum or in equated installments, or both in parts.

**TP Premium**: IRDAI has put on hold the annual premium rate increase for third party motor insurance policies for the next financial year. Insurers will continue to charge the rates currently being charged for Motor Third Party Liability Insurance Cover from April 1, 2019 until further orders.

## **For our Field Force**

#### ARIVUKKADAL, THANJAVUR

New regulations: IRDAI had released new regulations for linked and non-linked life insurance policies. The new regulations will allow the insurers to charge an extra premium from policyholders, instead of deducting units, for riders with unit-linked insurance plans. It will also allow partial withdrawal in case of linked pension plans in situations of critical illness, permanent disability because of an accident, or any other major health issue. Also, the new regulations are going to make it easier for policyholders to buy an annuity at the end of a pension product's policy terms as they will have the option to buy it from an insurer of their choice. Earlier, they had to buy an annuity product from the same insurer.

Online is the Future: The online insurance market is so promising that Flipkart's co-founder Binny Bansal and Amazon have made mega investments in the same online insurer, Acko General Insurance. Sources said the firms plan to weave in insurance into various verticals as well as provide standalone insurance products. They will soon start selling general and life insurance.

**2 mn in 16 months**: Digit Insurance has announced that it crossed a landmark achievement of two million customers within a short span of 16 months of operation. Digit started its operations in October 2017, and it has expanded its distribution through its direct channel partners including e-commerce giants like Policybazaar, Flipkart and Cleartrip.

**No sale without licence**: Auto dealers who sell motor insurance policies to people without a valid Motor Insurance Service Provider (MISP) licence could now be penalised. According to IRDAI, the penalty could be up to Rs five lakh. This will be applicable to all dealers selling motor insurance at the time of purchase of a vehicle.

**Pre-approved SA**: Private life insurer HDFC Life is looking to offer pre-approved sum assured to customers in order to boost penetration in India. At present, banks offer such pre-approved loans to their credit card customers.

**NFC-enabled travel insurance**: Reliance General has introduced an NFC-enabled travel insurance, 'Tap and Buy'. Simply by tapping smart phones on the airport display screen, the phone is prompted to open Whatsapp and the individual can buy travel insurance in less than a minute.

## **COWARDLY AND BARBARIC**
