**Massive Buildup to Strike Actions on 17<sup>th</sup> and 18<sup>th</sup> March 2021**  
**Solidarity and Support to our Strike Pours In from a cross section of Society**

The AIEA and other unions in the four Public Sector General Insurance Companies will go on a nationwide strike on 17<sup>th</sup> March. Similarly, all unions in LIC will strike work on 18<sup>th</sup> March, 2021. These strike actions are to protest against the decision of the government to list LIC in the stock markets through an IPO, increase FDI limits in the sector from 49% to 74%, privatise one public sector general insurance company and on the demand to settle the wage revision issue at the earliest.

The run-up to the strike actions has been remarkable in terms of the sweep and depth of the campaign. AIEA units have already met over 200 MPs in the current phase of campaign after having met 402 MPs in the recent months. There is no shade of public and political opinion that has not been touched. Our cadres all over the country have unambiguously demolished all the arguments of the government in justification of LIC IPO, FDI hike and privatization of one general insurance company. **The social media campaign taken up by our South and South Central Zonal Units has been eminently successful. The twitter campaign launched by South Zone on the 9<sup>th</sup> of March crossed 60,000 posts in a few hours and it was the third highest twitter trending topic in India on that day.** In the process, we have not only had a very effective campaign but earned considerable goodwill and support for public sector insurance industry. The proposed strike actions have received overwhelming support from a large number of trade unions, from India and abroad.

The **World Federation of Trade Unions (WFTU), Athens, Greece** has extended support and fraternal solidarity to our strike actions. The **ten central trade unions** and the **Samyukta Kisan Morcha** have also extended their solidarity and support. The Polit Bureau of the **Communist Party of India (Marxist)** has issued a statement in support of our Strike. The **All India Bank Officers' Confederation (AIBOC)** has extended fraternal support to our strike and has called upon its units to participate in our dharna/ demonstration programmes all over India.
